LAST WILL OF WILLIAM COLLIS HOLCOMBE.

I, William Collis Holcombe, domiciled in Shelby County, Alabama, declare this to be my last will, hereby revoking all wills and codicils heretofore made by me.

Article One

I direct that all of my just debts, my funeral expenses and the costs of administration of my estate be paid out of the assets of my estate as soon as practicable after my death.

Article Two

I devise and bequeath my presently-owned house and land consisting of approximately seventy acres, located in the N_2 of NE_4 of Section 26 Township 19 Scuth Range 1 West, Shelby County, Alabama, in equal parts to my wife, Bernell Johnson Holcombe, to my son William Oliver Holcombe and to my son Thomas Charles Holcombe, provided each shall survive me. I devise and bequeath all the residue and remainder of my property and estate of every nature and whereseever situated to my wife, Bernell Johnson Holcombe, if she shall survive me.

Article Three

If my said wife shall not survive me then I bequeath and devise the said property in fee and in equal shares to my sons, William Oliver Holcombe and Thomas Charles Holcombe. Provided, if either of the two persons named herein shall not survive me, then their issue shall take the part their parents would have taken if living. But if either of the named persons shall die without leaving any issue surviving, then his share shall go to the other or to his surviving issue.

Article Four

If my wife, Bernell Johnson Holcombe, and I shall die under such circumstances that there is not sufficient evidence to determine the order of our death it shall be presumed that I survived her and my estate shall be administered and distributed in all respects in accordance with such presumption.

Article Five

I appoint my wife, Bernell Johnson Holcombe, to be the Executrix of this my last will. If my wife shall predecease me, or for any reason shall fail to qualify as Executrix hereunder, or having qualified, shall cease to serve, then and in such event, I appoint my son, William Oliver Holcombe, or in the event of his demise, my son, Thomas Charles Holcombe, as alternate or successor executor.

I direct that no bond or other security shall be required of my Executrix, or her successor, herein named for the faithful performance of their duties.
