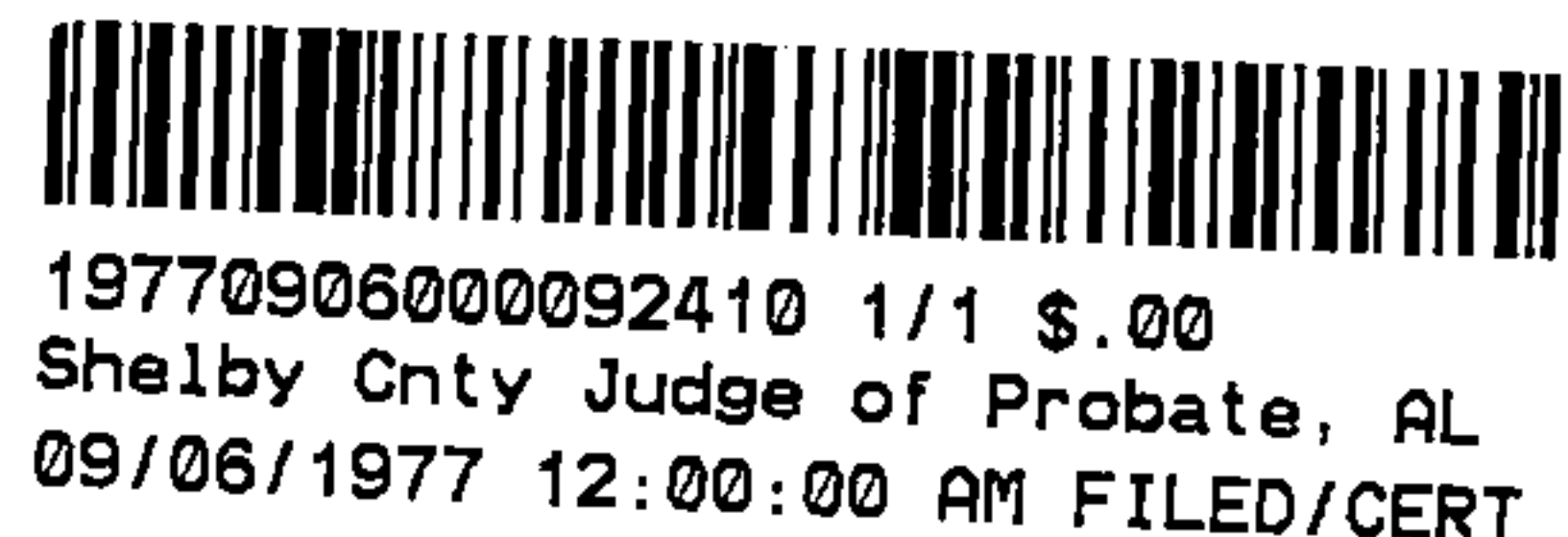


Assignment of Mortgage
