My name is O. C. Cox. I am 74 years of age and a resident of Maylene, Shelby County, Alabama. I am and have been since 1947 very familiar with the use, occupation, possession and ownership of the following described real estate located in Shelby County, Alabama, to-wit:

Lot #12 according to R. E. Whaley's Map of Maylene, Shelby County, Alabama, dated May 24, 1947 and recorded in Map Book 3, at Page 75, in the Office of the Probate Judge of Shelby County, Alabama.

This is a residential lot fronting on Whaley Avenue and is located in the heart of the Maylene community of Shelby County. I have known this land since 1934 when I began living in the nearby Brantleyville community of Shelby County. In 1947 I moved from Brantleyville to Maylene and began living in the house on Lot #23, according to the R. E. Whaley Map of Maylene, Shelby County, Alabama, dated May 24, 1947, which I own and live on at the present time. Part of the back lot line of my Lot #23 adjoins part of the back lot line of the above described Lot #12. Between 1947 and the present of said subdivision, time I also lived on and ran a store located on Lot #21/ which I also own at the present time.
