

The undersigned, Charles F. White and wife, Judy L. White, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and further, as additional security for a note given of even date herewith to Birmingham Trust National Bank, hereby sell, assign and transfer unto Birmingham Trust National Bank, or its assigns, all interest of grantors herein in the Chandalar Convenience Center, including both real and personal property, as additional security as set out hereinabove. It is understood and agreed that this assignment shall become null and void upon the following events, whichever shall occur first: (1) The note signed of even date herewith is paid in full; (2) This assignment is released by Birmingham Trust National Bank.

The legal description of the real property located in Shelby County, Alabama, is more particularly described as follows, to-wit:

An undivided one-half interest in a parcel of land located in the NW-1/4 of the NE-1/4 of Section 12, Township 20 South, Range 3 West, more particularly described as follows: Commence at the SW corner of said 1/4-1/4 section, thence in an Easterly direction along the South line of said 1/4-1/4 section a distance of 627.4 feet to the point of beginning; thence continue along last described course a distance of 255.0 feet to the intersection of the Northwest right-of-way line of U. S. Highway 31, thence 64° 08' 15" left along said right-of-way in a Northeasterly direction a distance of 144.47 feet; thence 115° 51' 45" left in a Westerly direction a distance of 318.02 feet; thence 90° left in a Southerly direction a distance of 130.0 feet to the point of beginning. Situated in Shelby County, Alabama.
