AFFIDAVIT OF RUBYE ROWE PHILLIPS

My name is Rubye Rowe Phillips. I reside at 4313 Avenue "L", Belview Heights, Birmingham, Alabama 35208. I am the daughter and only child of R. A. Rowe and Clevia Rowe, who was also known as Cleva Rowe. My father, R. A. Rowe, died in 1964. He left a will which was duly probated in Shelby County, Alabama. My mother died on February 12, 1970, a resident of Shelby County, Alabama. A copy of her death certificate is attached to this affidavit as Exhibit "A". I am the only heir-at-law and next-of-kin of my mother. I am the same Rubye Rowe Phillips named in my father's will as the vested remainderman after my mother's life estate. My mother died intestate leaving no outstanding debts.

I am the owner of real property situated in Shelby County, Alabama, more particularly described as follows:

A portion of the S 1/2 of the NW 1/4 of the NE 1/4, the N 1/2 of the SW 1/4 of the NE 1/4, and the N 1/2 of the SE 1/4 of the NE 1/4 of Section 2, T-21-S, R-3-W more particularly described as follows: begin at the SW corner of the N 1/2 of the SW 1/4 of the NE 1/4 of Section 2, T-21-S, R-3-W and run easterly along the south side of the said N 1/2 for 603.00 feet to the point of beginning. Then continue easterly along the south side of the said N 1/2 for 529.88 feet to a point on the west right-of way of State Highway No. 119, then turn an angle of 57° 13' 19" to the left and run northeasterly along the said rightof-way for 307.74 feet, to the beginning of a circular curve concave northwesterly and having a radius of 1638.59 feet, then turn an angle of 2° 48' 21" to the left and run northeasterly along a chord of said curve for 160.43 feet to a point on the west right-of-way of said Highway, said point also being in the centerline of John Allen Branch, then turn an angle of 83° 18' 52" to the left and run northwesterly for 126.60 feet to a point in the centerline of said branch, then turn an angle of 1° 42' 10" to the left and run northwesterly for 94.04 feet to a point in the centerline of said branch, then turn an angle of 3° 39' 53" to the right and run northwesterly for 215.68 feet to a point in the centerline of said branch, then turn an angle of 3° 27' 06" to the 1eft and run northwesterly for 185.79 feet to a point in the centerline of said branch, then turn an angle of 1° 00' 24" to the right and run northwesterly for 90.27

After my mother died I immediately assessed this property in my name for ad valorem taxes, and I have paid the taxes since that time, and no one else has assessed it or claimed in any way to own the property. From the time my parents bought this property it was continuously occupied by one or both of them until she died in 1970, and no one else claimed to own any of it except for two parcels out of the original purchase which my parents sold off and conveyed to Goggins and Junlap by recorded deeds. There have never been any boundary line disputes or other problems with the title. I have examined the recent survey of the property done at my request by William L. Egan, licensed surveyor, under date of September 2, 1977. This survey conforms to my recollection and understanding of the boundary lines and correctly locates the structures on the property. The East-West boundary had a fence on it when my parents bought the property. This fence has never been moved, so it is the same old fence line as shown on the recent survey by William L. Egan.
