ITEM TWO: I will, devise and bequeath to my wife, Nan Griffin Ozley, of Birmingham, Alabama, all real, personal or mixed property of which I may die seized and possessed or to which I may be entitled in equity at the time of my death.

ITEM THREE: I hereby nominate and appoint my wife, Nan Griffin Ozley, as Executrix of this will without bond and without the necessity of accounting to any court for her actions as such.

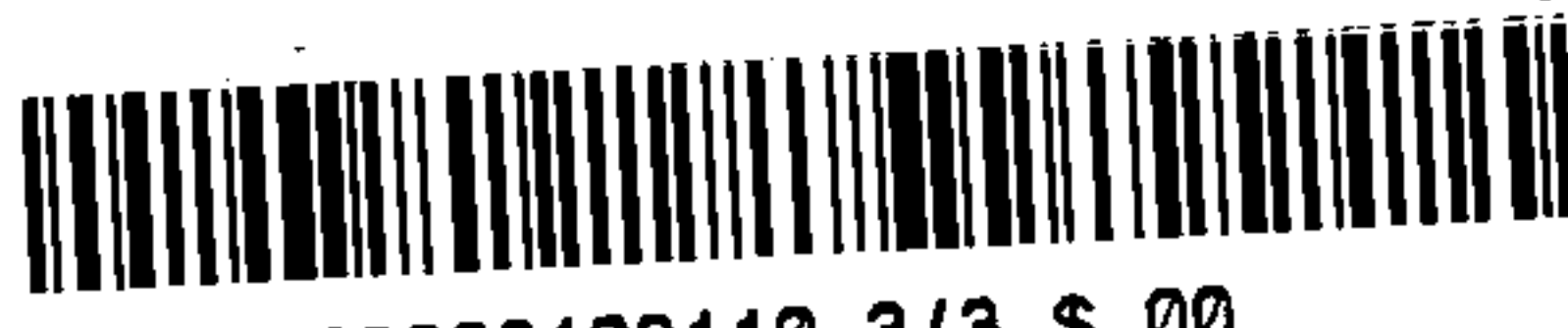
