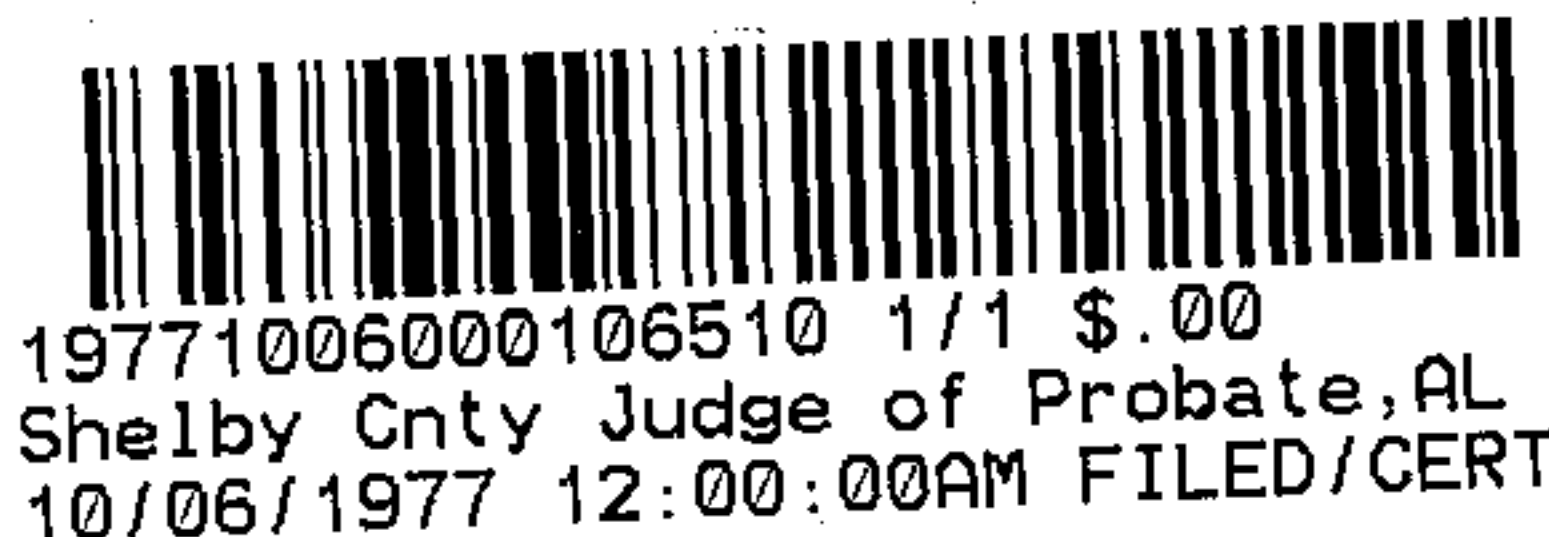
the receipt of which is hereby acknowledged, the said J. Harris Development Corporation
