Mitchell and wife, Ann Mallinson Mitchell, their heirs and assigns, the right to use said road as a means of access to their said lands or for any other roadway purposes, subject to the terms and conditions hereinafter set forth.

The parties recognize that Kimberly-Clark has heretofore granted to Coosa Valley Electric Cooperative, Inc., its successors and assigns, an easement along said roadway for the purpose of constructing, operating and maintaining an electric power line or system and the Mitchells agree that they will not utilize in any way the rights granted hereby so as to conflict with the rights granted to the said Coosa Valley Electric Cooperative, Inc.
