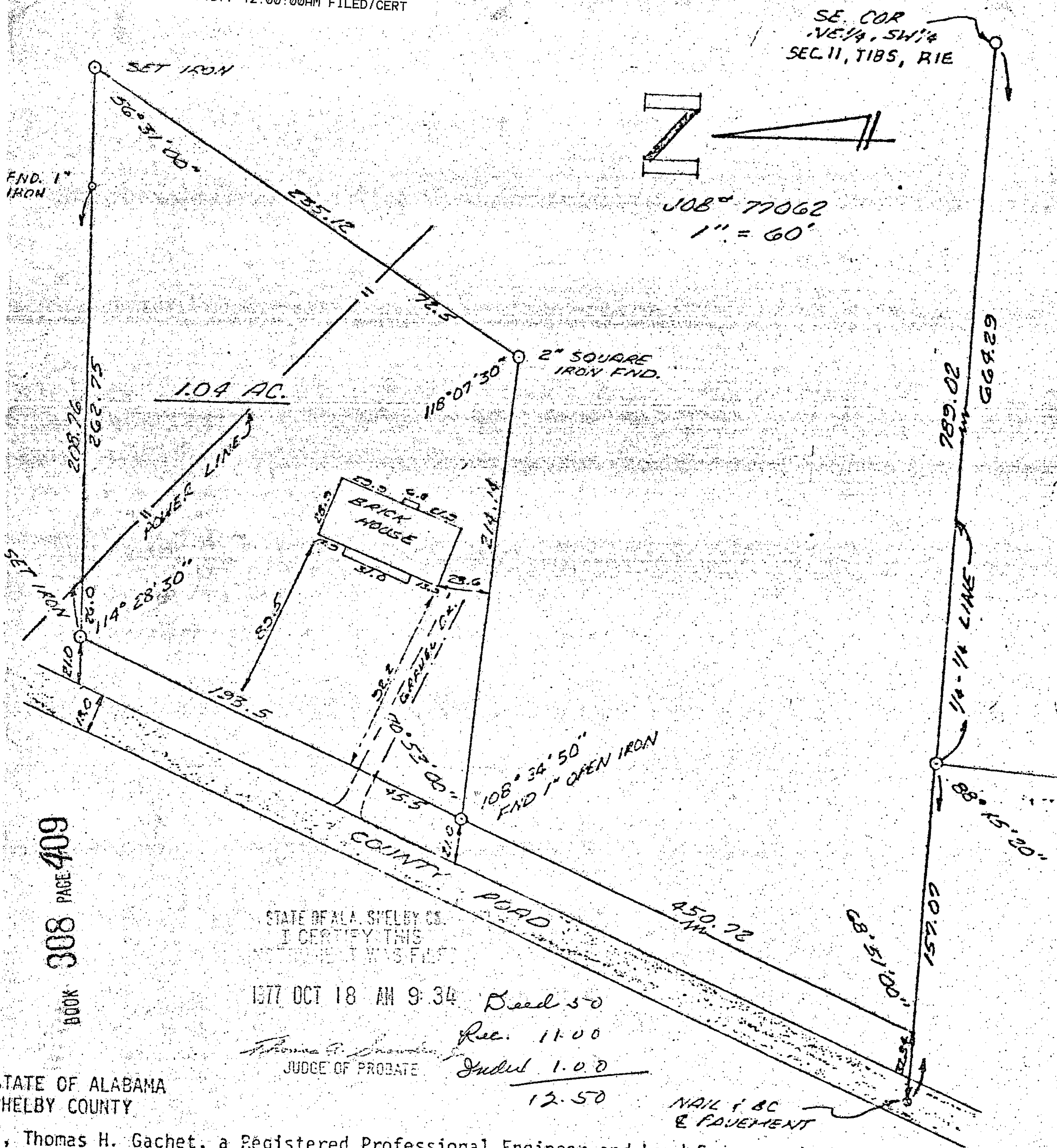

, Thomas H. Gachet, a Registered Professional Engineer and Land Surveyor in the State of Alabama, hereby certify the above to be a true and correct copy of a map or plat of a parcel of land situated in the Northeast 1/4 of the Southwest 1/4 of Section 11, Township 18 South, Range 1 East, Shelby County, Alabama and being more particularly described as follows: Commence at the Southeast corner of the Northeast 1/4 of the Southwest 1/4 of Section 11, Township 18 South, Range 1 East, Shelby County, Alabama, and run in a Westerly direction along the South line of said 1/4 Section a distance of 789.02 feet to a point on the Southeast right-of-way line of Shelby County Highway #50; thence turn a deflection angle of 111° 09' 00" to the right and run in a Northeasterly direction along the Southeast right-of-way line of said Road a distance of 450.72 feet to the point of beginning of the herein described parcel; thence deflect to the right 0° 32' 00" and run in a Northeasterly direction along the Southeast right-of-way line of said Road a distance of 193.50 feet to a point; thence turn an interior angle of 114° 28' 30" and run to the right in an Easterly direction a distance of 262.75 feet to a point; thence turn an interior angle of 56° 31' 00" and run to the right in a Southwesterly direction a distance of 235.12 feet to a point; thence turn an interior angle of 118° 07' 30" and run to the right in a Westerly direction a distance of 214.14 feet, more or less, to the point of beginning; containing 1.04 acres.)
