

TIMBER DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of Twelve Thousand Twenty-five and no/100 (\$12,025.00) Dollars, to the undersigned grantor, we, the said Roger C. Champion and wife, Donna S. Champion, George F. Parr and wife, Corinne Parr, George Christopher Parr and wife, Mayre Parr, to hereby grant, bargain, sell and convey unto the said Kimberly-Clark Corporation, all pine saw-timber and pulpwood measuring ten (10) inches in diameter and larger at the stump, from the following described lands:

A parcel of land situated in the W $\frac{1}{2}$  of the SE $\frac{1}{4}$  of Section 17, Township 22 South, Range 3 West, described as follows: Begin at the Southwest corner of the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 17 and go North 0 deg. 03 $\frac{1}{2}$  min. West along the West boundary of said  $\frac{1}{4}$ - $\frac{1}{4}$  Section 133.00 feet; thence North 68 deg. 00 min. East for 105.00 feet; thence North 0 deg. 03 $\frac{1}{2}$  min. West for 210.00 feet; thence South 68 deg. 00 min. West for 105.00 feet to the West boundary of said  $\frac{1}{4}$ - $\frac{1}{4}$  Section; thence North 0 deg. 03 $\frac{1}{2}$  min. West along this boundary for 935.45 feet; thence South 88 deg. 18 min. East for 16.73 feet; thence North 1 deg. 43 min. East for 452.38 feet; thence North 88 deg. 18 min. West for 30.37 feet to the West boundary of the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 17; thence North 0 deg. 03 $\frac{1}{2}$  min. West along this boundary 914.87 feet to the Northwest corner of the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$ ; thence South 87 deg. 32 min. East along the North boundary of said  $\frac{1}{4}$ - $\frac{1}{4}$  Section 478.45 feet to the centerline of McHenry Creek; thence Southerly along this centerline for 2510 feet, more or less, to the East boundary of the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 17; thence South 0 deg. 07 min. East along this boundary for 1179.94 feet to the Southeast corner of the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$ ; thence North 88 deg. 00 min. It is understood and agreed that no line trees shall be cut. The grantee is hereby given the right to use existing private roads and has the right to build such temporary roads and other devises as may be necessary or useful to the grantee for the purpose of cutting and removing the timber, however, all roads are to be left in as good condition as at the beginning of this contract.

And we do for ourselves and for our heirs, executors and assigns, that we are lawfully seized of said premises in fee simple; that it is free from all encumbrances and we have a good right to sell and convey said timber as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Kimberly-Clark Corporation, its successors and assigns against the lawful claims of all persons.






