KNOW ALL MEN BY THESE PRESENTS: That in consideration of Ten Dollars (\$10.00), and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, Leslie H. Hubbard Jr., and wife, Laverne S. Hubbard, and Humphrey L. Lee, and wife, Nora H. Lee, and Philip C. Hubbard, a single man, (herein referred to as grantors), grant, bargain, sell and convey unto Leslie H. Hubbard, Sr., (herein referred to as grantee), our undivided interest in and to the following described real estate, to-wit:

Sixty (60) acres more or less in the SE quarter of the SW quarter and the SW quarter of the SE quarter of Section 30 Township 24 Range 12 East, Bibb County, Alabama, described as follows: Beginning at the SW corner of the SE quarter of the SW quarter, run North along West line 1018 feet more or less to county road, then run easterly along the South side of the said county road 1/2 mile more or less to the East line of the SW quarter of the SE quarter, thence run South 969 feet more or less to the SE corner of the SW quarter of the SE quarter, thence run West a half mile more or less to the point of beginning.




