TO THE MEMBERSHIP OF CHRIST CHURCH, UNITED METHODIST

This is legal notice to the members of Christ Church, United Methodist that on July 10, 1977 at 11:30 a.m., there will be held a Charge Conference and a church conference at the Christ Church located at 5191 Caldwell Mill Road, Birmingham, Alabama, for the purpose of considering and voting upon the question of whether or not the Board of Trustees of said Church shall be given the power and be authorized to execute a mortgage to National Division Board of Global Ministries of the United Methodist Church in the amount of \$140,000.00 to obtain construction and permanent financing of a multi-purpose and classroom building as evidenced by two notes, one in the amount of \$75,000.00, bearing interest at the rate of 5% per annum and one in the amount of \$65,000.00, bearing interest at 8% per annum, and a mortgage to be payable in monthly installments as set out in said notes over a period of ten and twelve years respectively, said indebtedness to be secured by a mortgage on the following described property, situated in Shelby County, Alabama, to-wit:

Begin at the Northeast corner of the Northeast quarter of the Southwest quarter of Section 10, Township 19 South, Range 2 West, Shelby County, Alabama, thence Westerly along the North line of said 1/4-1/4 section a distance of 1013.53 feet to the centerline of a paved public road, thence 86° 07' left along said centerline a distance of 422.43 feet, thence 93° 53' left Easterly a distance of 1052.74 feet to the East line of said 1/4-1/4 section, thence 91° 26' 30" left along said 1/4-1/4 line a distance of 421.6 feet to the point of beginning.
