KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE DOLLAR AND OTHER GOOD AND VALUABLE CONSIDERATION

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, James Floyd Knowles, Jr. and wife, Mildred Knowles; John L. Knowles and wife, Sarah Knowles; Harold Pickett and wife, Barbara Joyce Pickett (herein referred to as grantors) do grant, bargain, sell and convey unto

John L. Knowles and wife, Sarah Knowles

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Begin at the southwest corner of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, Township 22 South, Range 2 West; thence run Northerly along the west boundary line of said $\frac{1}{4}$ $\frac{1}{4}$ Section for 1348.2 feet to the northwest corner of said $\frac{1}{4}$ $\frac{1}{4}$ Section; thence run easterly along the north boundary line of said $\frac{1}{4}$ $\frac{1}{4}$ Section for 1032.9 feet; thence run southerly parallel to the east boundary line of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, Township 22 South, Range 2 West, for 403 feet; thence run easterly parallel to the north boundary line of said $\frac{1}{4}$ $\frac{1}{4}$ Section for 200 feet, more or less, to a point on the northwest right of way line of Shelby County Road No. 12; thence run southwesterly along the northwest R.O.W. line of said Road for 1320 feet, more or less, to a point on the south boundary line of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, Township 22 South, Range 2 West; thence run westerly along the south boundary line of said $\frac{1}{4}$ $\frac{1}{4}$ Section for 242.0 feet to the point of beginning.

The above described land includes that land as described in the deed from J. F. Knowles and wife, Thelma Knowles to John L. Knowles, dated April 8th, 1966, and filed in Deed Book 241, page 645, in the Probate Office of Shelby County, Alabama.

The above described land subject to an easement 30 feet in width beginning at the southwest corner of the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, Township 22 South, Range 2 West, and running easterly to the right of way line of Shelby County Road No. 12 for the purpose of a roadway.
