TO HAVE AND TO HOLD, To the said GRANTEE, his (her) heirs and assigns forever.

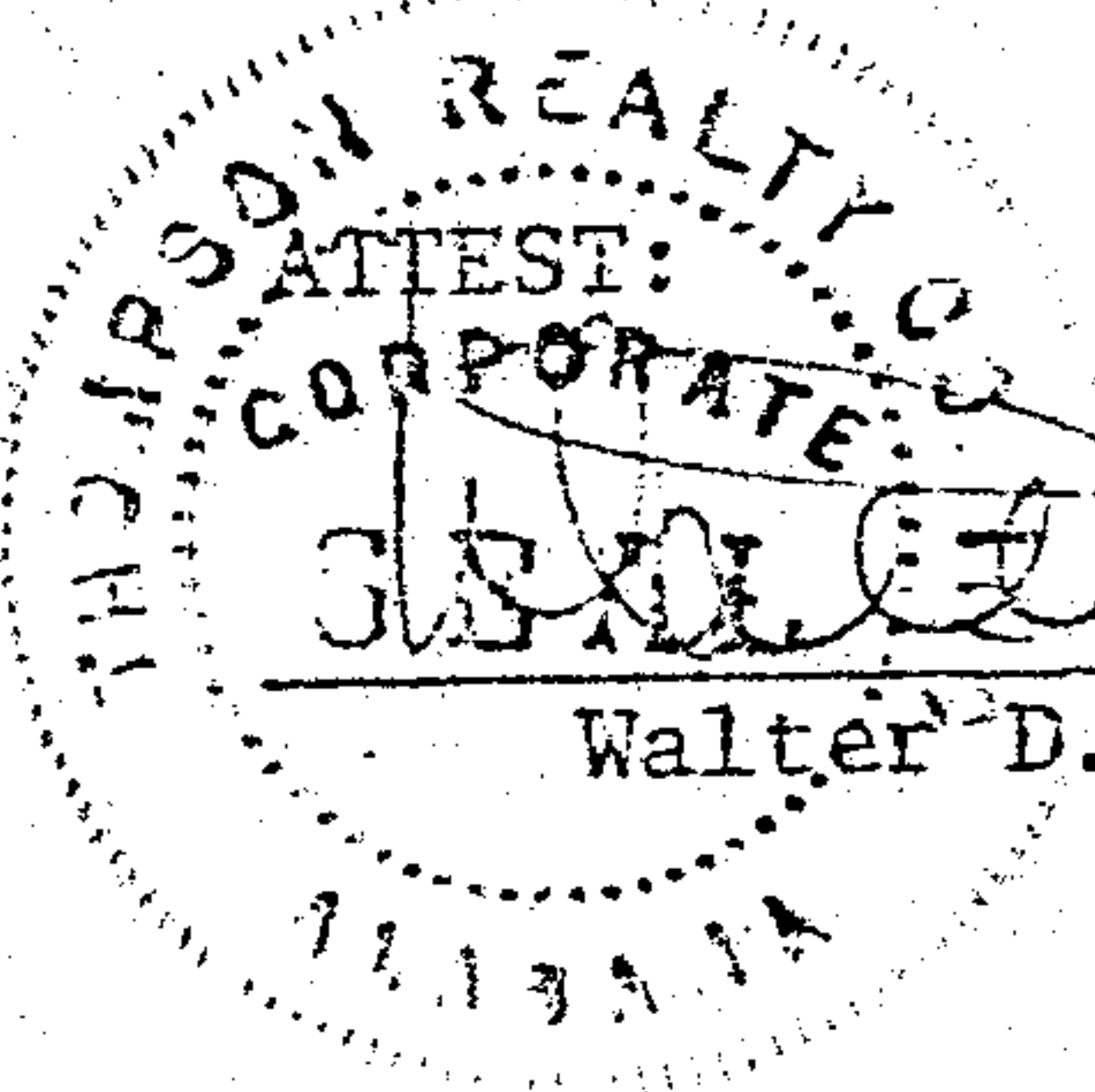

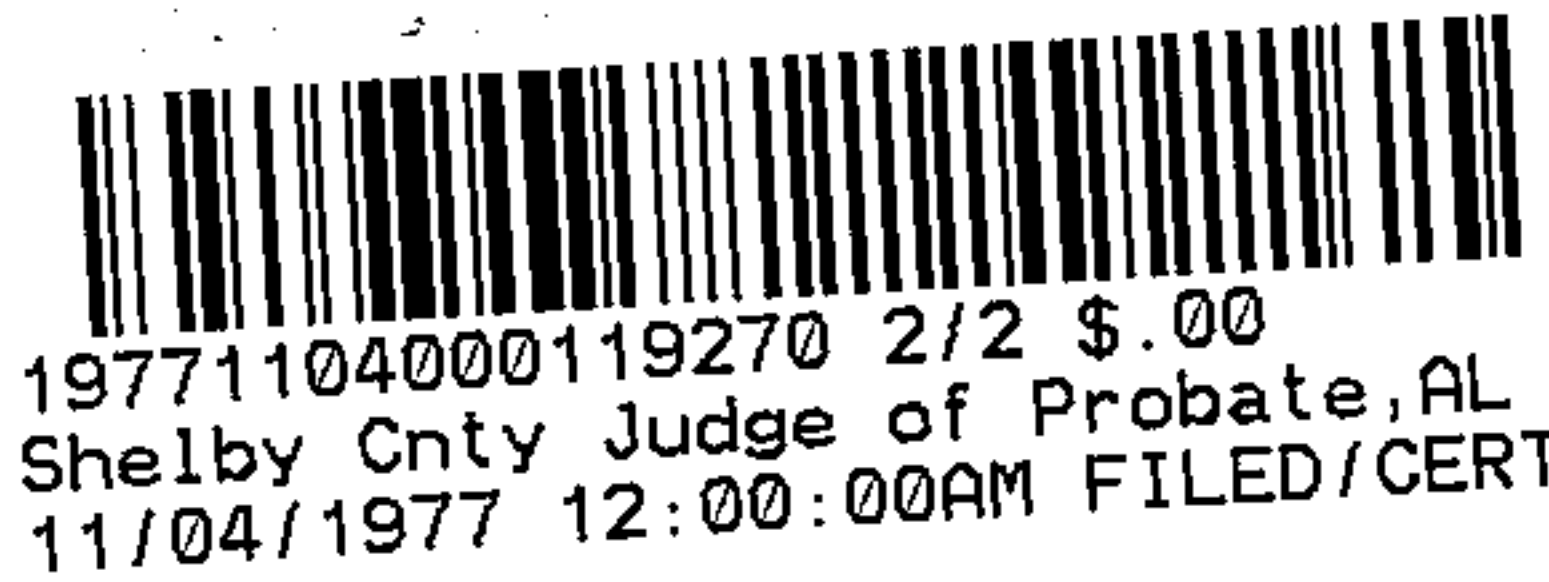

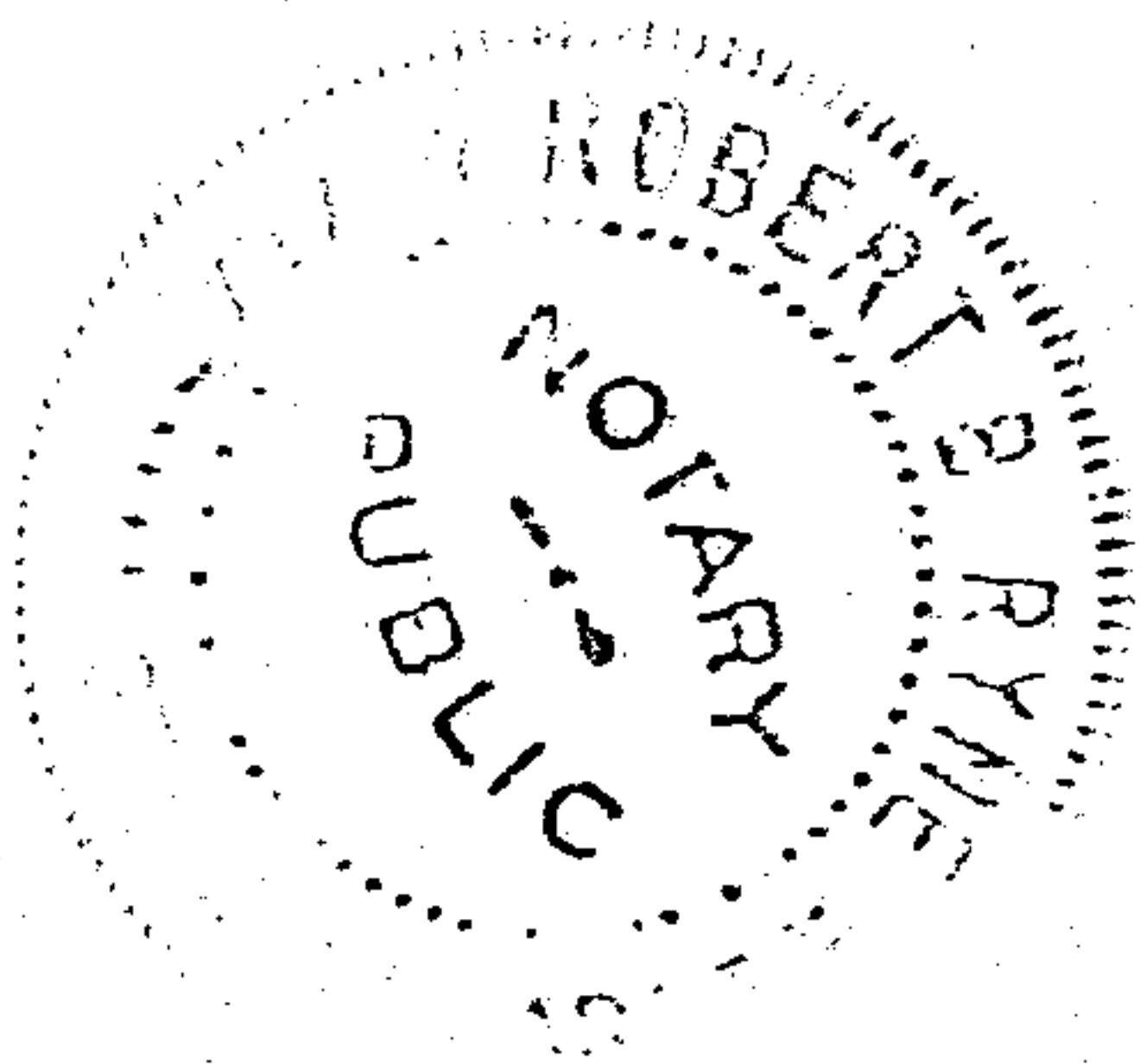
