MEMORANDUM OF ASSIGNMENT OF INDEBTEDNESS AND SECURITY THEREFOR

The Participation Agreement and Participation Certificate No. _____ (collectively hereinafter "Agreements"), of which this is a Memorandum, providing for a transfer of ownership of the indebtedness under certain loans and their respective security (all as in said Agreements defined, limited and provided) were respectively entered into on March 2, 1977 by and between Engel Mortgage Company, Inc., as Seller (hereinafter "Assignor"), and St. Petersburg Federal Savings and Loan Association, as Buyer (hereinafter "Assignee").

Pursuant to said Agreements, Assignor assigned and hereby assigns to Assignee and Assignee accepted and hereby accepts from Assignor an undivided interest of less than 100% in and to the remaining indebtedness of certain loans identified hereinafter and in and to their respective mortgages, deeds of trust, or other security, upon all the covenants, terms and provisions, and subject to all the limitations and conditions set forth in said Agreements. In this regard, all such terms and provisions of said Agreements are hereby incorporated herein and made a part hereof in all respects as though fully set forth herein, reference being had to fully executed copies of said Agreements in the possession of Assignor at its Home Office at John A. Hand Building, Suite 501, Birmingham, Alabama 35201 for full particulars.

Certain of the loans and security therefor to which said Agreements and this Memorandum of Assignment pertain are particularly identified in the attached Schedule by names of borrowers, Assignor's loan numbers, and the data as to the recording of the respective security instruments in the Official Records of _____ County,

No provision of this Memorandum of Assignment nor of said Agreements shall preclude or restrict a Trustee (or any successor Trustee) under any of such security instruments from executing, delivering or recording such conveyances or other documents as are provided for under said respective security instruments or under law.
