Vines, their successors and assigns the right to construct, use, maintain and enjoy full use thereof a roadway and various utilities over the following lands in Shelby County, Alabama.

A thirty foot wide strip of land in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , S-4, T-22S, Range 1 W, extending from a county road known as the Butter and Eggs Road in an eastwardly direction to the property of said James G. Vines and wife, Doyleene G. Vines. Said easement following route of an old road known as Gould Road. The center line of said easement described as: From the NW corner of said SE $\frac{1}{4}$  NW $\frac{1}{4}$ , S-4, T-22S, R-1W run south along west boundary of said SE $\frac{1}{4}$  517.03' to the point of beginning located in the traveled portion of said Butter and Eggs Road; thence turn 94 $^{\circ}$ 36' to the left, thence run 405.1'; thence turn 37 $^{\circ}$ 00' to the right; thence run 183.05'; thence turn 23 $^{\circ}$ 26' to the right; thence run 165.5'; thence turn 41 $^{\circ}$ 29' to the left; thence run 78.1' to the NW Corner of said James G. Vines and wife, Doyleene G. Vine's property.
