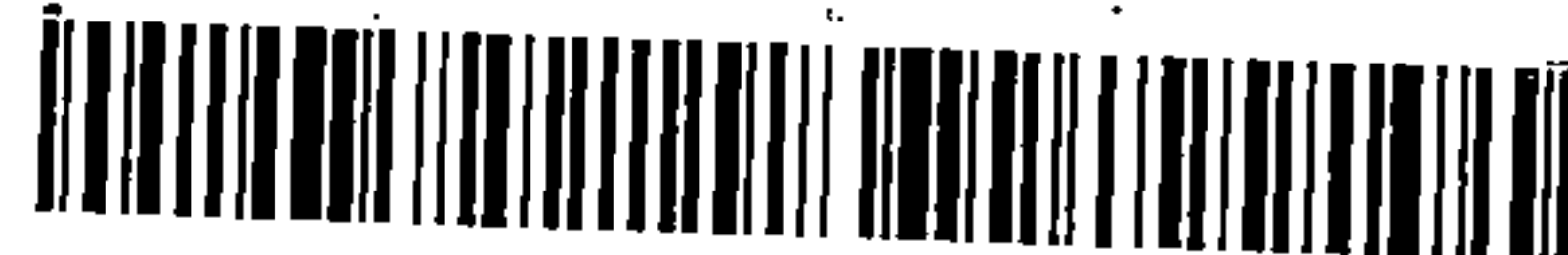

A portion of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, Township 22-S, R-2-W described as follows: Begin at the S. E. corner of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 6, T-22-S R-2-W and run northerly along the east side of the said $\frac{1}{4}$ - $\frac{1}{4}$ for 24.29 ft. to the point of beginning. Then turn an angle of 180 deg. 00 min. to the right and run southerly along the east side of the said $\frac{1}{4}$ - $\frac{1}{4}$ for 15.74 ft., then turn an angle of 94 deg. 12 min. 01 sec. to the right and run westerly for 435.17 ft., then turn an angle of 116 deg. 53 min. 16 sec. to the right and run northeasterly for 291.22 ft. to a point on the southwest right of way of Linda Lane, then turn an angle of 105 deg. 42 min 24 sec. to the right and run southeasterly along the southwest R. O. W. of said lane for 269.39 feet to the point of beginning of a tangent curve concave northeasterly and having a radius of 289.34 ft., then run southeasterly along the south R. O. W. of said lane through a central angle of 24 deg. 08 min. 05 sec. for 121.88 ft. back to the point of beginning.

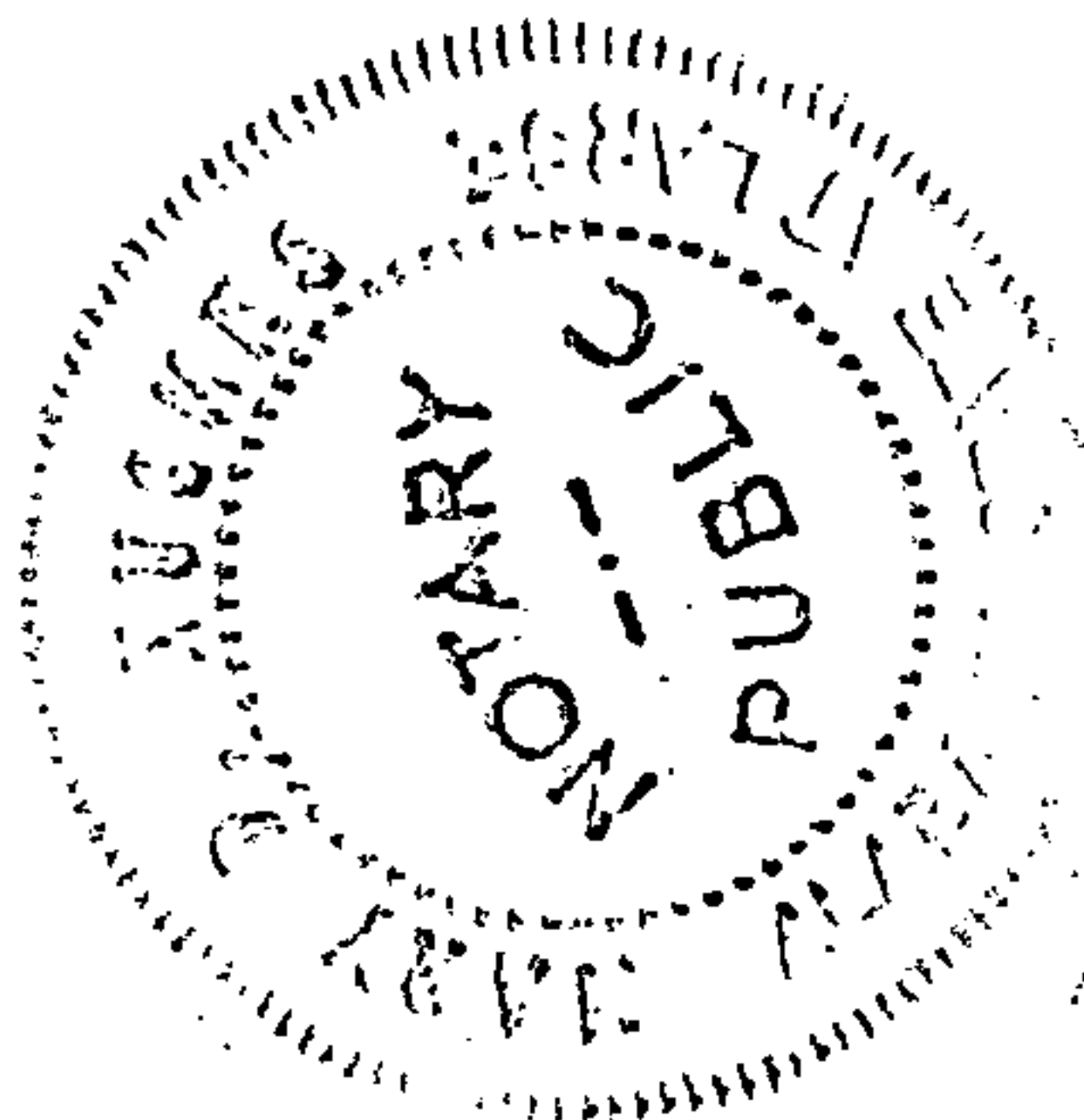
