COURT ORDER RELIEVING DISABILITIES OF NON-AGE

This cause coming on to be heard upon the verified petition of Thelma Geraldine Price, formerly Thelma Geraldine Lawson, to have her daughter, Betty L. Lawson, relieved of the disabilities of non-age, which petition and the order of this Court setting it for hearing were served upon Betty L. Lawson by the Sheriff of Shelby County on December 2, 1977, and said Thelma Geraldine Price, formerly Thelma Geraldine Lawson, with her attorney and Betty L. Lawson being in open Court and the Court taking evidence on a tenus and it appearing to the Court therefrom that the said Betty L. Lawson does not have a legal guardian and that publication of notice is not necessary and the Court being of the opinion that it is, and will be, to the best interest of said minor to be relieved of the disabilities of non-age, and upon consideration thereof, it is ORDERED by the Court that Betty L. Lawson, a minor, who is over the age of eighteen years, be and she is hereby fully and unconditionally relieved of the disabilities of non-age and she is vested with the power to sue and be sued, contract and be contracted with, to buy, sell and convey real estate and generally to do and perform all acts which said minor could lawfully do if nineteen years of age.

It is further ordered that the said Thelma Geraldine Price, formerly Thelma Geraldine Lawson, pay the costs of this proceeding, for which execution may issue, and that a copy of this Court Order be recorded in the Office of the Judge of Probate of Shelby County, Alabama.


