the receipt whereof is acknowledged, the said Hinton Construction and Development, Inc.
does by these presents, grant, bargain, sell, and convey unto the said Claude E. Lee and Mary Douglas Paxton,
as joint tenants, with right of survivorship, the following described real estate, situated in
Shelby County, Alabama, to-wit:
