ITEM II

ITEM III

In the event said beneficiary were to predecease me or die with me in a common disaster, I give, devise and begueath all of my said property unto the following named beneficiaries or the survivor or survivors of them, share and share alike, namely: Estelle E. Little, Mary E. Brennan, the heirs now living of Lois E. Metcalfe, Inez R. Kidd, Rufus Rose, and Central Church of Christ of Birmingham, Alabama. It is my intent that the heirs of Lois E. Metcalfe shall receive one sixth of my estate to be divided among such heirs.

My Executrix, hereinafter named, shall have the power to hold and manage my property and such other property as may be subsequently acquired with full power to compromise claims in favor of or against my estate, power to collect income therefrom, to sell, convey, lease, exchange, improve, encumber, borrow on the security of or otherwise dispose of, all or any portion of my estate in such manner as the said Executrix may deem advisable, all without order of Court, and

Final distribution cf my estate shall be made by my Executrix within three years from the date of probate of this Will unless time for settletent is extended by order of Court.

I hereby nominate and appoint Jewell R. Ellison as Executrix of this my Last Will and Testament and I direct that my said Executrix shall not be required to give bond or to file an inventory or appraisal of my estate in any court, and direct that in the performance of her duties hereunder, my Executrix shall be free from the control and supervision of the Probate Court or any other court.

In the event my said Executrix were to predecease me or be unable or unwilling to serve, then I name Mary E. Brennan as alternative Executrix with the same powers and immunities herein granted my originally named Executrix.
