EXHIBIT "A"

Part of the SE 1/4 of the SW 1/4 of Section 29 and part of the NE 1/4 of NW 1/4 of Section 32 all in Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows: From the southwest corner of the SE 1/4 of SW 1/4 of said Section 29 run in an easterly direction along the south line of said 1/4-1/4 section for a distance of 890.96 feet, thence turn an angle to the right of 56° 24' 38" and run in a southeasterly direction for a distance of 127.90 feet, thence turn an angle to the left of 90° and run in a northeasterly direction for a distance of 60.00 feet, thence turn an angle to the right of 90° and run in a northeasterly direction for a distance of 60.00 feet, thence turn an angle to the right of 90° and run in a southeasterly direction for a distance of 85.62 feet, more or less, to a point on the northwest right-of-way line of Cahaba Valley Road being the point of beginning, thence turn an angle to the right of 180° and run in a northwesterly direction for a distance of 85.62 feet to a point of curve, said curve being concave to the east and having a central angle of 23° 13' 22" and a radius of 285.34 feet, thence turn an angle to the right and run in a northerly direction along the arc of said curve for a distance of 115.65 feet (the chord line of said curve being 114.86 feet), thence turn an angle to the right of 81° 56' 41" from said chord line and run in a northeasterly direction for a distance of 221.26 feet, thence turn an angle to the left of 27° 15' 39" and run in a northeasterly direction for a distance of 140.00 feet, thence turn an angle to the right of 131.20' and run in a southeasterly direction for a distance of 274.00 feet, more or less to a point on the curved northwest right-of-way line of Cahaba Valley Road, said curved right-of-way line having the following characteristics, being concave in a southeasterly direction and having a radius of 2,904.79 feet, thence turn an angle to the right and run along said curve right-of-way line for a distance of 289.99 feet, more or less, to the point of beginning, containing 1.528 acres, more or less.
