

I, Dowell M. Ray, hereby certify that the above is a true and correct map of the property shown being more particularly described as follows, to-wit: at the Northeast corner of the Southeast one-fourth of the Southeast one-fourth of Section 10, Township 21 South, Range 1 East, Shelby County, Alabama; thence proceed West along the North boundary of said quarter-quarter section for a distance of 72,79 feet to the point of beginning, said point being located on the West right-of-way line of Shelby County Highway; From this beginning point continue West along the North boundary of said quarter-quarter section for a distance of 420 feet; thence turn an angle of 90° to the left and proceed South Parallel to the West boundary of said road for a distance of 136 feet; thence proceed East for a distance of 420 feet to a point on the West right of way line of said road; thence proceed North along the West right-of-way line of said road for a distance of 136 feet to the point of beginning."
