FOR VALUE RECEIVED, the undersigned Lester C. Wyatt, individually and as Trustee of the Stewart-Wyatt Trust, and Rita M. Stewart Hudson and Birmingham Trust National Bank, as Co-Executors and Co-Trustees of the Estate of Charles W. Stewart, Deceased, hereby grant, bargain, sell and convey unto Lester C. Wyatt the following described real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land located in the North Half of the SW 1/4 of Section 31, Township 19 South, Range 2 West, more particularly described as follows: Commence at the NE corner of the SW 1/4 of the NW 1/4 of said Section 31; thence in an easterly direction, a distance of 452.73 feet; thence 86° 31'40" right, in a southerly direction, a distance of 1321.78 feet; thence 47°06' right, in a southwesterly direction, a distance of 250.20 feet to the Point of Beginning, said point being in the approximate center line of an existing road; thence 79°55'15" right, in a northwesterly direction along said approximate center line, a distance of 149.66 feet to the beginning of a curve to the left, having a radius of 113.67 feet and a central angle of 66°50'; thence southwesterly along said curve and approximate center line, a distance of 132.59 feet to end of said curve; thence in a southwesterly direction along a line tangent to said curve, a distance of 85.50 feet to a point on the easterly R/W line of now existing Highway 31 South, said point being on a curve having a radius of 2010.08 feet and subtended by a chord length of 868.19 feet, and from last described course, turn an angle of 67°46'46" left to said chord; thence in a southerly direction along said curve and R/W line, a distance of 875.07 feet to the point of Spiral to Curve of said R/W; thence from last described chord, turn 15°07'04" right to chord of said Spiral, said chord having a length of 307.65 feet; thence in a southerly direction along said Spiral and R/W line, a distance of 307.95 feet to the point of Tangent to Spiral of said R/W line, said point being at Highway Station 66 plus 61.9; thence from last described chord, turn 1°31'12" right, in a southerly direction along said R/W line, a distance of 143.58 feet; thence 90° left, in a southeasterly direction, a distance of 46.43 feet; thence 41°55' left, in a northeasterly direction, a distance of 378.44 feet; thence 8°03'30" right, in a northeasterly direction, a distance of 137.37 feet; thence 8°02' right, in a northeasterly direction, a distance of 529.00 feet to a point in the approximate center line of said existing road; thence 97°15'06" left, in a northwesterly direction along said approximate center line, a distance of 152.06 feet; thence 5°32'03" left, in a northwesterly direction, a distance of 210.29 feet to the beginning of a curve to the left, having a radius of 965.17 feet, and a central angle of 23°24'51"; thence northwesterly along said curve and approximate center line, a distance of 394.42 feet to end of said curve; thence in a northwesterly direction along a line tangent to said curve, a distance of 380.41 feet to the Point of Beginning, containing 17.1 acres, more or less.
