

TERMINATION OF INDENTURE OF TRUST

THIS AGREEMENT, made and entered into this 24 day of Dean, ber, 1977, by and among Birmingham Trust National Bank and Rita M. Stewart Hudson as Co-Executors and Co-Trustees of the Estate of Charles W. Steart, Deceased, and Lester C. Wyatt,

## WITNESSETH:

WHEREAS, Charles W. Stewart and Lester C. Wyatt, as Beneficiaries, and Lester C. Wyatt, as Trustee, did heretofore enter into a certain Indenture of Trust dated June 22, 1974, which said Indenture of Trust was recorded in the Office of the Judge of Probate of Shelby County, Alabama on August 22, 1974, in Book 288, Page 386, and created the trust known as the "Stewart-Wyatt Trust", sometimes known as the "Stewart-Wyatt Land Trust"; and,

WHEREAS, the said Indenture of Trust was thereafter amended and modified by Amendment to Indenture of Trust dated April 30, 1975, and recorded in Book 11, Page 141, said Probate Office; and

WHEREAS, all of the assets of the Stewart-Wyatt Trust have been conveyed to Lester C. Wyatt, individually; and,

WHEREAS, there is no further purpose for the existence

of said Stewart-Wyatt Trust and the parties hereto have agreed

to enter into a termination agreement for the purpose of terminating and dissolving the said Stewart-Wyatt Trust,

NOW, THEREFORE, in consideration of the premises, the sum of One (\$1.00) Dollar and other good and valuable consideration in hand paid by each of the parties to the other, the receipt and sufficiency whereof is hereby acnowledged, the parties hereto mutually covenant and agree as follows:

- 1. That the Stewart-Wyatt Trust is hereby terminated and dissolved.
- 2. The parties hereto acknowledge that all of the assets heretofore owned by the Stewart-Wyatt Trust have been duly and properly transferred, assigned and conveyed to Lester C. Wyatt, individually.
