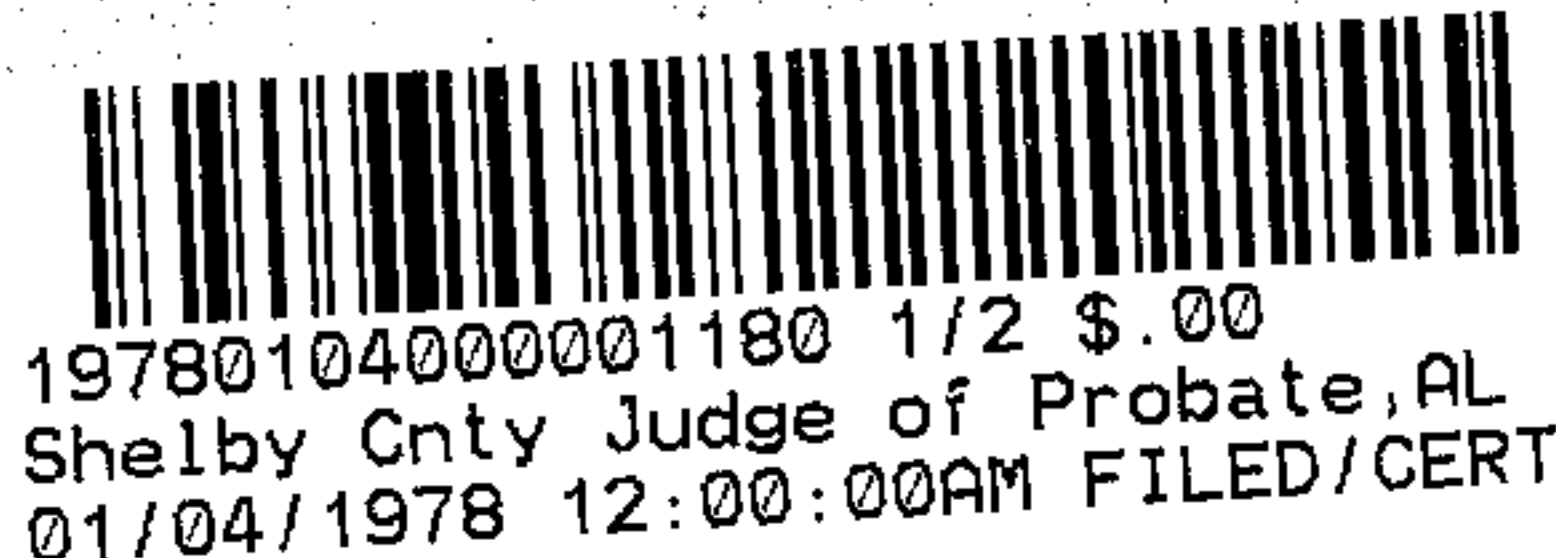

A parcel of land, 60 feet in width, located in the Northwest 1/4 of the Southwest 1/4 of Section 7, Township 19 South, Range 1 West, and the Northeast 1/4 of the Southeast 1/4 of Section 12, Township 19 South, Range 2 West, Shelby County, Alabama, more particularly described as follows: Commence at the Northwest corner of the Northwest 1/4 of the Southwest 1/4 of said Section 7, thence in an Easterly direction, along the North line of said 1/4 - 1/4 Section, a distance of 166.31 feet, thence 134 degrees 58 minutes right, in a Southwesterly direction, a distance of 347.73 feet to the Point of Beginning, thence continue along last described course a distance of 80.53 feet, thence 131 degrees 50 minutes 10 seconds left, in an Easterly direction, a distance of 97.30 feet to the beginning of a curve to the right, said curve having a radius of 100.81 feet and a central angle of 41 degrees 50 minutes 10 seconds, thence along arc of said curve, in a Southeasterly direction, a distance of 73.61 feet to end of said curve, thence continue in a Southeasterly direction a distance of 310.27 feet to the Northwesterly Right of Way of Cahaba Valley Road, thence 90 degrees left, in a Northeasterly direction, along said Right of Way, a distance of 60.0 feet, thence 90 degrees left, in a Northwesterly direction, a distance of 310.27 feet to the beginning of a curve to the left, said curve having a radius of 160.81 feet and a central angle of 41 degrees 50 minutes 10 seconds, thence along arc of said curve, in a Northwesterly direction, a distance of 117.42 feet to end of said curve, thence continue, in a Westerly direction of 43.57 feet to the Point of Beginning.
