Section 10, Township 21 South, Range 1 East; thence run South along the West line a distance of 833.89 feet; thence turn an angle of 91 deg. 00 min. 51 sec. to the left and run a distance of 702.93 feet; thence turn an angle of 59 deg. 48 min. to the left and run a distance of 403.38 feet to the point of beginning; thence turn an angle of 68 deg. 05 min. to the left and run a distance of 296.53 feet; thence turn an angle of 90 deg. 00 min. to the right and run a distance of 180.00 feet; thence turn an angle of 90 deg. 00 min. to the right and run a distance of 210.00 feet; thence turn an angle of 44 deg. 49 min. to the right and run a distance of 56.47 feet; thence turn an angle of 75 deg. 33 min. to the left and run a distance of 272.58 feet to the Northwest right of way line of County Highway No. 7; thence turn an angle of 89 deg. 58 min. 12 sec. to the right to tangent of a right of way curve and run along said curve (whose Delta Angle is 1 deg. 17 min. 00 sec. to the right, Radius is 1373.30 feet, Tangent is 15.36 feet, Length of Arc is 30.73 feet); thence turn an angle of 88 deg. 41 min. 12 sec. to the right from Tangent and run a distance of 278.88 feet; thence turn an angle of 77 deg. 31 min. 21 sec. to the left and run a distance of 116.96 feet to the point of beginning.
