✓ RIVERCHASE REPURCHASE OPTION AGREEMENT

23 732 THE HARBERT-EQUITABLE JOINT VENTURE (hereinafter referred to as "DEVELOPER"), hereby consents to the conveyance of lot number 11 located in Riverchase West Residential Subdivision, a subdivision of Riverchase, according to plat recorded in Map Book 6, page 78, in the office of the Judge of Probate of Shelby County, Alabama, from W-H Construction Co., Inc. to C. A. Traffica Builders. DEVELOPER further waives its right to repurchase said lot from W-H Construction Co., Inc. granted to DEVELOPER in Section 12.21 of the Declaration of Protective Covenants, Agreements, Easements, Charges and Liens for Riverchase (Residential), recorded in Miscellaneous Book 14, beginning at page 536 in the office of the Judge of Probate of Shelby County, Alabama, as amended in Miscellaneous Book 17, beginning at page 550 in the office of the Judge of Probate of Shelby County, Alabama, on condition that said lot number 11 in Riverchase West Residential Subdivision is in fact conveyed by W-H Construction Co., Inc. to C. A. Traffica Builders.

For and in consideration of one dollar (\$1.00) and other good and valuable consideration, each party paid to the other, and for the further consideration of DEVELOPER'S consent to the conveyance and for DEVELOPER'S waiver of its Repurchase Option with W-H Construction Co., Inc., C. A. Traffica Builders (hereinafter referred to as "OWNER"), hereby agrees that in the event that it, as OWNER, desires to convey lot number 11 in Riverchase West Residential Subdivision prior to the expiration of one year after the date of the present conveyance, and in the further event that OWNER has not begun construction of the building thereon, DEVELOPER shall have and retains the option to purchase said lot from OWNER for an amount not to exceed \$14,500.00, without interest. OWNER shall give DEVELOPER written notice of OWNER'S desire to convey said lot and DEVELOPER shall have thirty (30) days after receipt thereof to exercise its option to purchase.

C. A. Traffica Builders understands that DEVELOPER does not waive its rights in Section 12.20 of the Declaration of Protective Covenants, Agreements, Easements, Charges and Liens for Riverchase (Residential) with respect to the Construction Period. C. A. Traffica Builders understands that construction of the residential building on this lot is to be completed within two (2) years from the date of this conveyance and within one (1) year from the date of beginning construction. Otherwise, in addition to all other rights and remedies for breach of the Riverchase Covenants (Residential), in the event this restriction is not fully complied with, DEVELOPER shall have the right, but not the obligation, to repurchase said lot for an amount not to exceed \$14,500.00, without interest.
