KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of

Fifty-three Thousand, Five Hundred and 00/100-----Dollars
to the undersigned grantor, Roy Martin Construction, Inc.
a corporation, in hand paid by Horace Dean Rigsby, Jr. and Sallye J. Rigsby,
the receipt whereof is acknowledged, the said
Roy Martin Construction, Inc.

does by these presents, grant, bargain, sell, and convey unto the said

Horace Dean Rigsby, Jr. and Sallye J. Rigsby
as joint tenants, with right of survivorship, the following described real estate, situated in
Shelby County, Alabama, to-wit:

Lot 17, according to the Survey of Dearing Downs, as recorded in Map Book 6, Page
136, in the Probate Office of Shelby County, Alabama.
Situating in the Town of Helena, Shelby County, Alabama.

SUBJECT TO: 1) Current taxes; 2) 35-foot building set back line from Dearing Downs
Drive and Whirlaway Circle; 3) Utility easements as shown on recorded map of said
subdivision; 4) Restrictions filed for record on February 9, 1977, and recorded in
Misc. Book 18, page 593, in Probate Office; 5) Transmission line permits to Alabama
Power Company dated Sept. 10, 1952, and recorded in Deed Book 155, page 107, in
