Beginning at the northeast corner of the NW-1/4 of the SW-1/4 of Section 6, Twp. 19 S, R 1 E; thence South 2 degrees West for a distance of 9.92 chains to the Point of Beginning. Thence South 89 degrees West for a distance of 1.24 chains; thence west for a distance of 1.91 chains; thence south 34 degrees west for a distance of 1.07 chains; thence south 56 degrees west for a distance of 1.38 chains; thence south 27 degrees west for a distance of 2.00 chains; thence south 41 degrees west for a distance of 2.00 chains; thence south 36 degrees west for a distance of 2.01 chains, thence south 25 degrees West for a distance of 3.80 chains; thence north 88 degrees west for a distance of 0.57 chains to the Southwest corner of the E-1/2 of the NW-1/4 of the SW-1/4 of Section 6, Township 19 South, Range 1 East.
