Commence at the Southwest corner of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Sec. 14, T-21-S, Range 3 West; thence run East along the South line of said NW $\frac{1}{4}$ Section a distance of 230.80 feet to the point of beginning; thence continue East along the South line of said NW $\frac{1}{4}$ Section a distance of 361.10 feet to the East right of way of Shelby County Highway No. 119; thence turn an angle of 91 deg. 30 min. 48 sec. to the left and run along said Highway right of way a distance of 184.85 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 3 deg. 49 min. 13 sec. to the right, Radius is 2317.39 feet; tangent is 93.96 feet; Length of Arc is 187.86 feet) to P. T. of said curve; thence turn an angle of 89 deg. 10 min. 22 sec. to the left from tangent of said curve and run a distance of 215.04 feet to the P.
