AMENDMENT TO RESTRICTIONS APPLICABLE TO  
INDIAN VALLEY, 3RD SECTOR, ACCORDING TO  
MAPS AND PLATS IN MAP BOOK 5, PAGE 97,  
IN THE OFFICE OF THE JUDGE OF PROBATE,  
SHELBY COUNTY, ALABAMA.

KNOW ALL MEN BY THESE PRESENTS:

That The Five T's, Inc., an Alabama Corporation, being the owner of INDIAN VALLEY, 3rd Sector, as recorded in Map Book 5, Page 97 and a re-survey, as recorded in Map Book 5, Page 129, in the Office of the Judge of Probate, Shelby County, Alabama, desires to further amend those certain restrictive covenants touching and concerning said subdivision, which restrictions are recorded in Miscellaneous Book 1, Page 72, as follows:

1. The following amendment is applicable only to that certain real property described as :

Lot 19-A, According to a resurvey to Indian Valley, 3rd Sector, as recorded in Map Book 5, Page 129, in the Office of the Judge of Probate, Shelby County, Alabama, AND

Lot 12, According to a survey to Indian Valley, 3rd Sector, as recorded in Map Book 5, Page 97, in the Office of the Judge of Probate, Shelby County, Alabama,

and this amendment does not apply to any other lot or tract, or parcel of real property situated in said subdivision hereinabove described.

2. Respecting the lots described in Paragraph I hereinabove, and only those lots , the language in Paragraph I, is changed to read as follows:

"I". Each lot conveyed by The Five T's, Inc., is subject to the reservations as to the right to mine all minerals under such lands, expressly included but not limited to coal, oil, gas and dolomite, which said minerals are retained by The Five T's, Inc. However, no such mining, surface or subsurface, shall take place upon or under the real property subject to this provision so long as a residence, single family or multi-family, is situated thereon, or under construction thereon.

3. In all other respects, the restrictions of record touching and concerning Indian Valley, 3rd Sector, recorded as aforesaid, are hereby ratified and confirmed.
