

WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of ONE HUNDRED AND 00/100 (\$ 100.00) DOLLARS to the undersigned Grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, J. C. GATES AND WIFE, ETHEL D. GATES; ELVIE GATES BROWN AND HUSBAND, COY BROWN; HOWARD P. GATES AND WIFE, CORINE GATES; EARL HOWARD GATES AND WIFE, NETTIE LOU GATES AND CHARLES GATES AND WIFE, SHIRLEY GATES, BEING ALL THE HEIRS AT LAW OF EARL H. GATES, DECEASED, herein referred to as Grantors, do grant, bargain, sell and convey unto CHARLES GATES AND WIFE, SHIRLEY GATES, herein referred to as Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

SW4 of SE4, except 15 acres off South side, Section 13, Township 19, Range 2 East.

ALSO:

Not SE% of SE%, Section 13, Township 19, Range 2 East.

ALSO:
