the receipt of which is hereby acknowledged, the said Reid & Sanders, Inc.

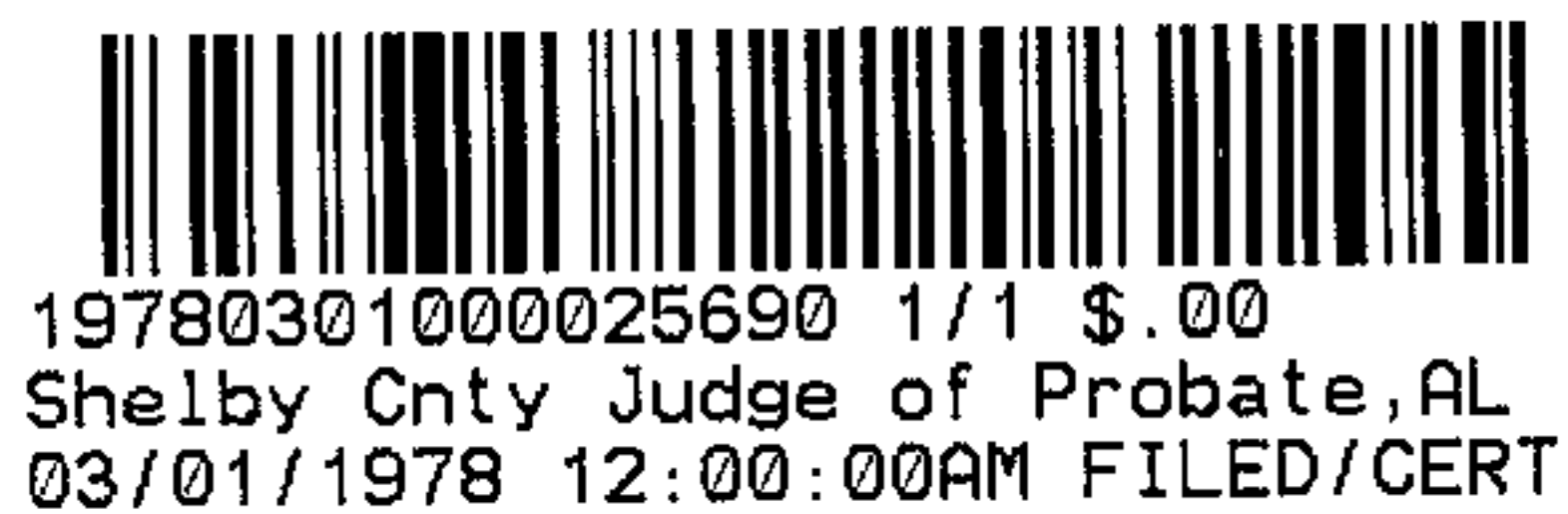
does by these presents, grant, bargain, sell and convey unto the said C & E Reid Construction Company, Inc.
