
KNOW ALL MEN BY THESE PRESENTS, that the undersigned,

operate and maintain, along a route to be selected by the grantee, (generally shown
crosshatched on the attached drawing) its successors and assigns, all conduits,
cables, translosures and other appliances and facilities useful or necessary in
connection therewith, for the underground transmission and distribution of electric
power and for underground communication service, upon, under and across the following
described land situated in Shelby County, Alabama:

Commence at the Southeast corner of the Northeast 1/4 of Northwest 1/4
of Section 11, Township 19 South, Range 2 West; thence in a Westerly
direction and along the South line of said 1/4-1/4 section 942.0 feet
to the point of beginning of the Center line of a 10' feet easement;
thence 0°12' left and run 447.75 feet; thence 16°57' right and run
Northwesterly direction 32.6 feet; thence 21°54' left and run South-
westerly direction 56.6 feet; thence 32°54' right and run Northwesterly
direction 39.08 feet; thence 23°01' left and run Northwesterly direction
156.45 feet; thence 9°22' right and run Northwesterly direction 34.83
feet; thence 7°14' left and run Northwesterly direction 51.84 feet;



