AMENDMENT OF DECREE

It being called to the Court's attention that an error was made in the description shown on the decree filed in this case on the 22nd day of February, 1978, and desiring to correct the same, it is,

ORDERED, ADJUDGED and DECREED by the Court as follows:

That property owned by the defendant, Vera Kathleen Williams as described in paragraph 3 of said decree dated February 22, 1978, be deleted and the following description shall be inserted in lieu thereof, viz:

A part of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 25, Township 20 South, Range 3 West and the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 26, Township 20, Range 3 West, more particularly described as follows:
Begin at the point of intersection of the Easterly right-of-way line of the Louisville and Nashville Railroad with the South line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 26, Township 20 South, Range 3 West; thence run East along said South line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 112.02 feet to the Southwest corner of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 25, Township 20, Range 3 West; thence East along the South line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 130.6 feet to a point on the Westerly right-of-way line of U. S. Highway 31; thence turn an angle to the left of 75 deg. 29 min. and run Northerly along said Westerly right-of-way line a distance of 26 feet; thence turn left and run in a Southwesterly direction a distance of 252 feet, more or less, to a point on the Easterly right-of-way line of the Louisville and Nashville Railroad; said point being located 12 feet North of the point of beginning; thence run in a Southerly direction along the East line of said railroad right-of-way a distance of 12 feet to the point of beginning.

All other things in said decree are hereby ratified and confirmed.
