OWNER'S CONSENT

WHEREAS, Birmingham Trust National Bank (hereinafter referred to as "Secured Party") is about to or has taken a first perfected security interest pursuant to the terms of a certain Security Agreement dated the 18<sup>th</sup> day of January, 1978, between Secured Party and Burgess Mining and Construction Corporation (hereinafter referred to as "Debtor"), that certain property fully described in Security Agreement, which said property has or is about to be erected, installed, or otherwise affixed to the aforesaid realty;

NOW, THEREFORE, in consideration of the financing of said property by Secured Party and other good and valuable considerations, the Undersigned does hereby covenant and agree to and with Secured Party, that the Undersigned for its successors and assigns expressly assents to the reservation of title to the said property in Secured Party, its successors and assigns, in the event of a breach of the terms of said Security Agreement, free of any claim of the Undersigned whether now existing or hereafter acquired.

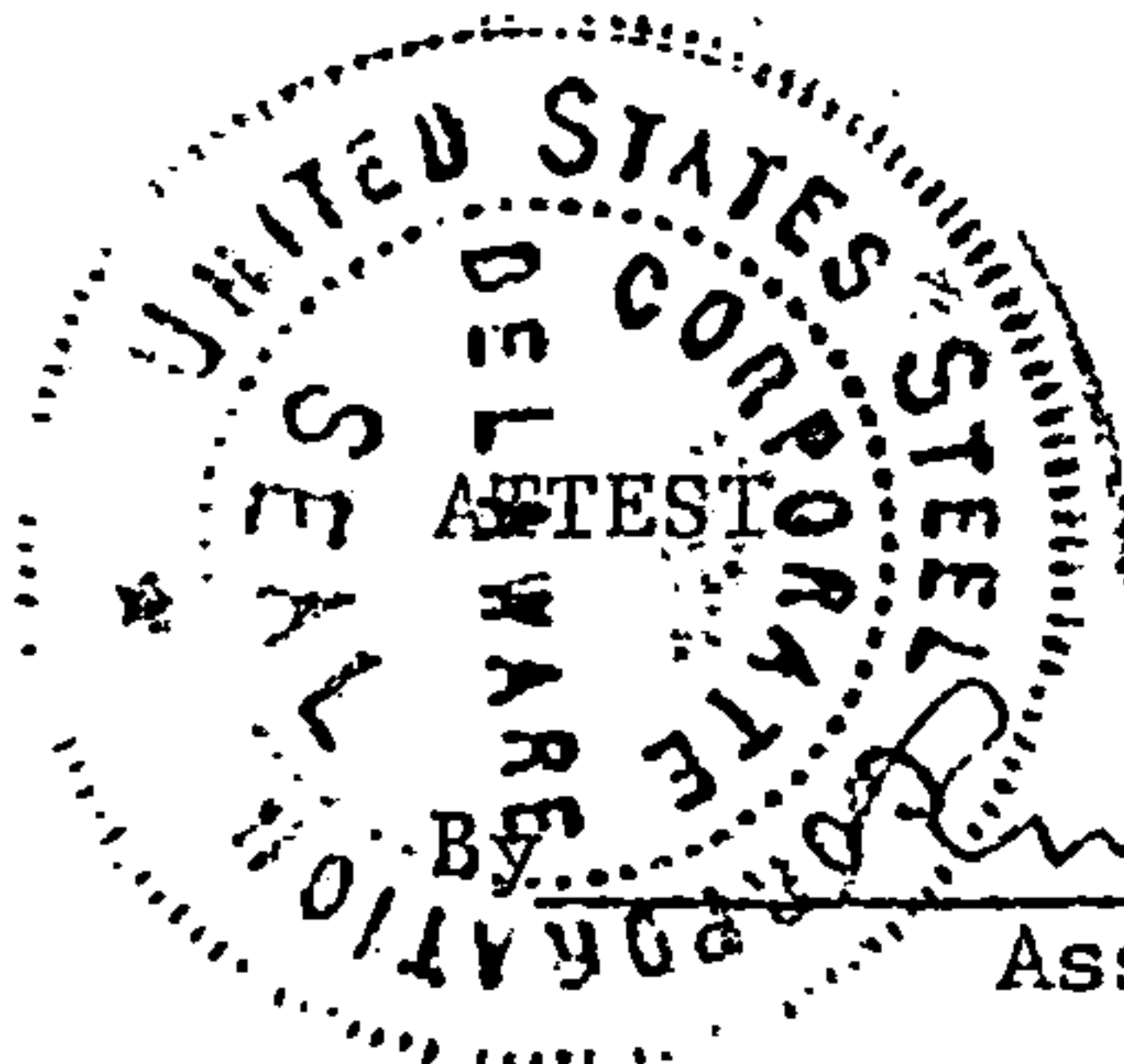
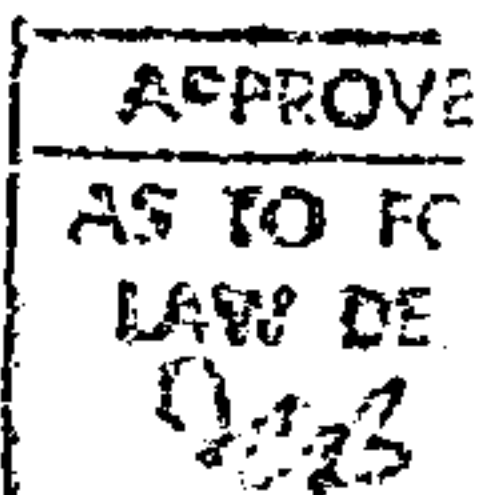

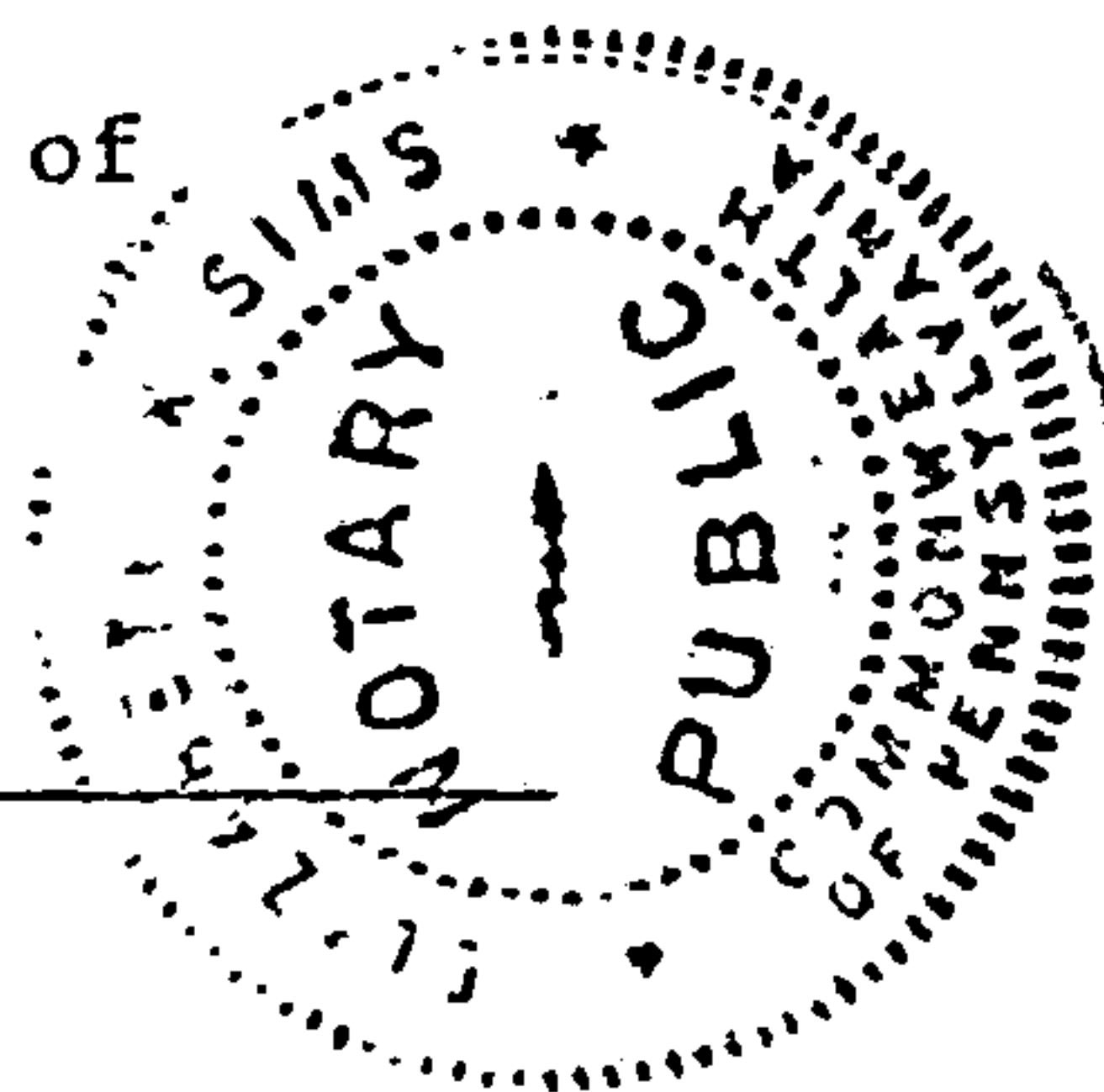

Scale 1 in. = 500 ft. April, 1975

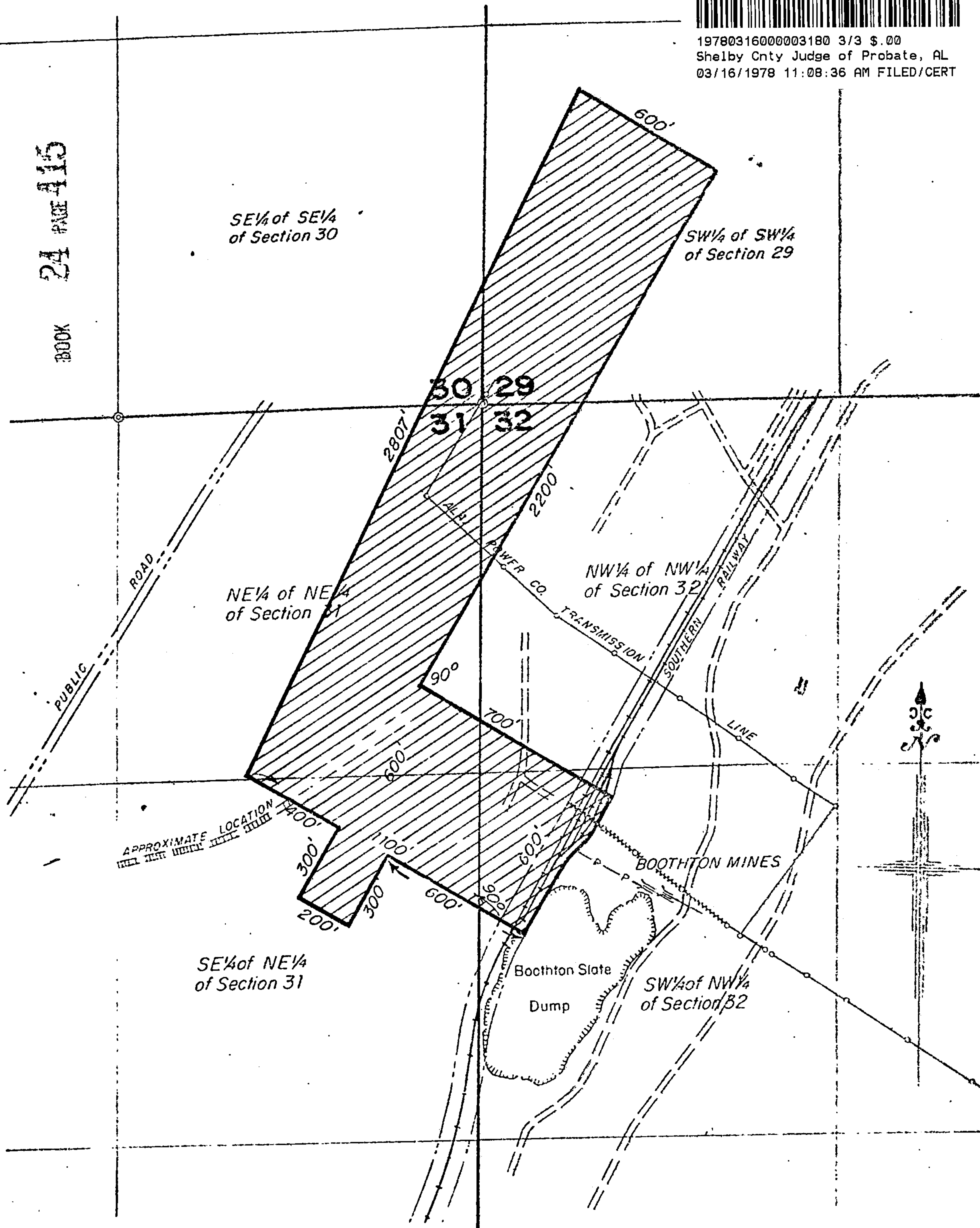
