WARRANTY DEED, Jointly for Life with Remainder to Survivor

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Eighteen Thousand Seven Hundred Four and NO/100-
----- Dollars (\$18,704.00)

to the undersigned Grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, Dorothy Dockery Morton and husband, Jessie Julian Morton, Virginia Dockery Smith and husband, J. D. Smith, Bonnell Dockery Wyatt and husband, William Turner Wyatt, Ruby Dockery Anders and husband, George W. Anders and Wesley Leon Dockery and wife, Alice Drew Dockery, (herein referred to as Grantors) do grant, bargain sell and convey unto Roy Partridge and wife, Ruby Partridge, (herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:
