East 687.75 feet; thence south one-half deg. East 162.6 feet to the Northwest corner of said Lot No. 3; from this point of beginning of the lot hereby conveyed; run North 89.5 deg. East 160.0 feet; thence South, one-half deg. East 109.0 feet; thence South 89.5 deg. West 160.0 feet; thence North one-half deg. West 109.0 feet to the point of beginning.

There was a house on said property in 1941 when my said father bought said property and went into possession of the same, and my said father and mother lived continuously in said house on said property as their home

I visited in said home on said property with my father and mother from the time that they bought and went into the possession of the same in 1937 until I actually moved to Wilton in 1950, and I have observed said property closely on an almost day to day basis since that time.

I was actually familiar with said property and the ownership thereof prior to the time when my father bought the same in 1941: Mr. and Mrs. O. T. Gay resided in said house on said property as their home up until just before they sold and conveyed said property to my father; Mr. and Mrs. Gay built a new home in a new location and when they moved into their new home, they sold the above described property to my said father.

During all the time that I have been familiar with said property since 1941 and until the present date I have never heard anyone question the title, ownership, or possession of my said father, W. K. Gaddy, to said property. At one time, there was apparently a mix-up in the property description on the old deeds, as I know that my father and mother at one point in time exchanged quit claim deeds with James W. Grant in order to get the deed descriptions to conform with the correct description of the property as it is situated on the ground.

I know of my own personal knowledge that my said father, W. K. Gaddy, has been in the actual, continuous, peaceable, undisturbed, notorious, exclusive, hostile, actual, adverse possession of said property from 1941 until the time of his death, this past December, 6, 1977, and that since his death, my self and my other brothers and sisters have been in possession of said property.
