

EASEMENT

KNOW BY ALL MEN BY THESE PRESENTS, that we, C. M. Wade and wife, Stella Wade, in consideration of One and no/100 dollars (\$1.00), receipt of which is acknowledged, and the use of a perpetual easement over the portion of Grantor's hereinbelow described land which is necessary for use for driving purposes, more particularly described as:

From the SW corner of the SW1/4 of the SW1/4 of Section 22, Township 20 South, Range 3 West run westerly along the south boundary of said 1/4-1/4 section for 69.0 feet to the point of beginning of the land herein described; thence run easterly along said south boundary of said 1/4-1/4 section for 1395.47 feet to a point; thence turn an angle of 90.0° to the north and run 40.0 feet; thence turn an angle of 90.0° left and run westerly 1388.97 feet to the east boundary line of that certain parcel of real property conveyed by the Grantors to the Grantees as set out in the deed recorded in Deed Book 269 at Page 814 in the office of the Probate Judge of Shelby County, Alabama; thence run along the easterly boundary line in a southwesterly direction to the point of beginning. Said property being situated in Shelby County, Alabama.

This easement is for the benefit of and appurtenant to that land, or any portion thereof.

TO HAVE AND TO HOLD to the said Grantees for and during their joint lives and upon the death of either or them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor foreve, together with every contingent remainder and right of reversion.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.
