My name is Vauda Brasher, and I am the widow of T. R. Brasher. I presently reside at Route 1, Sterrett, Alabama. My husband, T. R. Brasher, died without a will on July 29th, 1976. He left surviving him as his sole heirs and next of kin, the following children: Larry Brasher and Louise Brasher Overton. Larry Brasher and Louise Brasher Overton are both over the age of 21 years. T. R. Brasher had no other children born of him during his lifetime. After my husband's death any claims or debts against his estate were paid and satisfied.

Mary Lee Willingham is my daughter by a previous marriage. My second husband, T. R. Brasher, never adopted my daughter.

For more than twenty-five years, I have been familiar with the herein-after described real property, said property being described as follows:

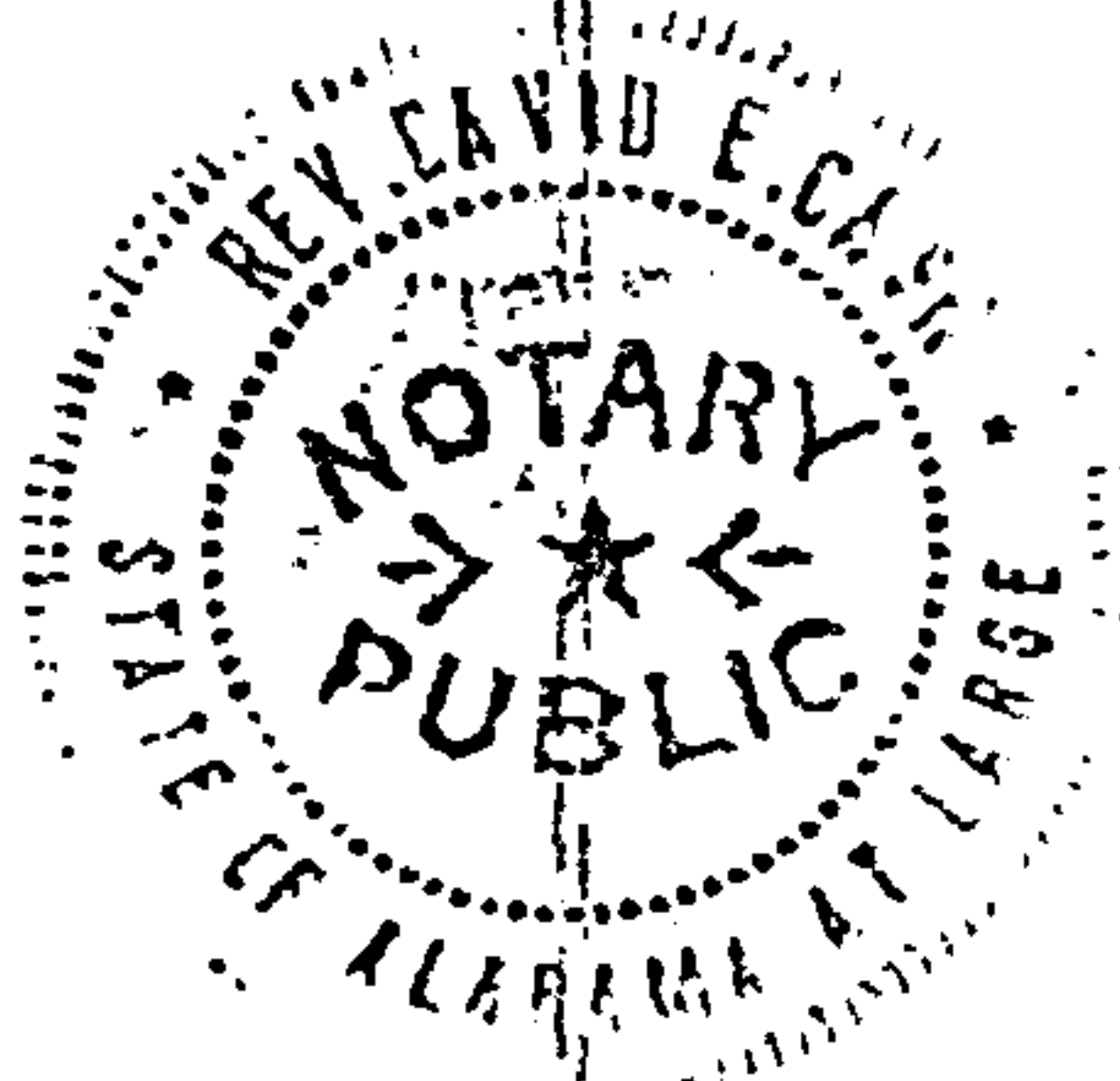

In 1946, my husband and I built our home on this property, and I have occupied the dwelling each and every year until the current date. My husband acquired title to this property in June of 1951 from G. L. Brasher and wife and E. B. Brasher and wife, as shown by those certain deeds recorded in Deed Book 149, page 562, and Deed Book 149, page 560, in the Office of the Judge of Probate of Shelby County, Alabama. I have lived in the dwelling house each and every year until the current date, and my husband and I have claimed this property through the years as our homestead. My husband farmed and cultivated a portion of this property for many years. When my husband and I went into possession of this property, my husband fenced several areas of the land. This fencing has been maintained to the present date. My husband and I have also cut timber from the wooded portions of the property on several occasions. At the present time, the sole heirs and next of kin of T. R. Brasher and myself as his widow own the hereinabove described property in fee simple, and since the time that I first knew the land it has been owned by us as the widow and the sole heirs and next of kin of T. R. Brasher, and our predecessors in title. The land has been occupied by us actually, exclusively, openly, notoriously, hostilely, and continuously. Since I have known the possession of the property and its ownership, I have never heard the title of the present owners or their predecessors
