Commence at the southwest corner of the SW% of NW%, Section 9, T 20 S. R 1 E and run east along the south boundary of said quarter quarter section a distance of 94.0 feet to a point on the northwest 50 foot right of way line of Project RS-5924; thence run northeasterly along said northwest 50 foot right of way line along a curve to the left (concave northwesterly) and having a radius of 2241.83 feet a distance of 34.0 feet to the point of beginning in the center of Yellowleaf Creek; thence continue northeasterly along said northwest 50 foot right of way line along said curve a distance ff 239.0 feet to a point in the center of Yellowleaf Creek; thence run northeasterly along the center of said Yellowleaf Creek a distance of 131.0 feet to a point on the northwest 40 foot right of way line of County Highway 55; thence run southwesterly along said 40 foot right of way line of said County Highway No. 55 a distance of 379.0 feet to a point in the center of Yellowleaf Creek; thence run northwesterly along the center of said Yellowleaf Creek a distance of 70.0 feet to the point of beginning.



The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
