ITEM I.

I direct that all my debts, including the expenses of my last illness and funeral, shall be paid out of my estate by my executors hereinafter named, as soon as possible after my death.

The administration of my estate shall be expedited as quickly as is practicable after my death and distribution made to beneficiaries herein named, not later than one year after the date of my death.

Any one or more of my Co-Executors shall have the right to resign at any time and for any reason, and without leave of court, by filing an instrument of resignation with the clerk of the court in which this Will is probated.
