KNOW ALL MEN BY THESE PRESENTS, That we, Daniel Mathias Jones and Magnolia C. Jones, husband and wife of Jefferson County, Alabama, do hereby make, publish and declare this our joint and several last will and testament as follows:

(1) Should the one of us who may first die owe any just debts, we desire that same be paid with all convenient dispatch.

(2) We give, devise and bequeath unto the survivor of us all property of every kind and character owned by us, whether jointly or severally, TO HAVE AND TO HOLD Unto said survivor in fee simple, except as provided in the next succeeding paragraph.

(3) Should we both die at the same time or within 10 days of each other, such as death growing out of a common disaster or illness, then, we leave all of our property, and the property of each of us, share and share alike to our children, and if any of our children should predecease us, leaving a child or children surviving, such child or children shall take that share of our estate which would have gone to the parent if living, but this provision shall not apply, except in case we shall die within a period of 10 days of each other.

(4) We nominate, constitute and appoint the survivor of us Executor or Executrix, as the case may be of this will and we expressly direct that such survivor shall not be required to execute bond, file inventory or make any settlement of our estate.
