That in consideration of THIRTY-EIGHT THOUSAND AND NO/100 (\$38,000.00)-----DOLLARS

to the undersigned grantor, J & R Homes, Inc., a corporation,
(herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the
said GRANTOR does by these presents, grant, bargain, sell and convey unto

Thomas Henry Fortenberry and wife, Darlene Fortenberry

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
situated in Shelby County, Alabama, to-wit:

From the Northwest corner of Fractional Section 12, Township 24 North, Range
12 East, run South along the West boundary line of said Section 12 a distance
of 510 feet; thence turn an angle of 79 deg. 27 min. to the left and run a
distance of 266.5 feet to the point of beginning of the parcel herein described;
thence continue along the same course a distance of 236.5 feet to a point;
thence turn an angle of 79 deg. 27 min. to the right and run a distance of
170.0 feet; thence turn an angle of 100 deg. 33 min. to the right and run a
distance of 236.5 feet; thence turn an angle of 79 deg. 27 min. to the right
and run a distance of 170.0 feet to the point of beginning.
