DECLARATION OF VACATION

327

KNOW ALL MEN BY THESE PRESENTS, that the undersigned Jack McGuire Excavating Company, Inc.; Owens Enterprises, Inc.; Martin & Sons, Inc.; Donnie Tucker; Edgar Thomas and Robert Owens, being the owners of all of the lands abutting on or directly served by paved road hereinafter described as vacated, do hereby declare vacated and annulled and all public rights and easements divested out of the public in and to the following described paved road, to-wit:

That certain paved road traversing the following described real property, to wit:

A part of the NE $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 36, Township 19, Range 3 West described as follows:

Begin at the Northwest corner of NE $\frac{1}{4}$  of NE $\frac{1}{4}$  of said Section and run thence along North line of said forty North, 88 degrees 30 minutes East 139.1 feet to beginning point of tract herein described, being on the East right of way line of Montgomery Highway; thence Southeast along the East right of way line of said highway South 36 degrees 30 minutes East, 360 feet to North margin of Little Cahaba Road; thence along North margin of said road as follows: North 64 degrees East, 244.1 feet; North 71 degrees East 131 feet; North 63 degrees 30 minutes East 85 feet; North 55 degrees 45 minutes East 214.7 feet to intersection of North line of said NE  $\frac{1}{4}$  of NE  $\frac{1}{4}$  of said Section; thence along North line of said forty South 88 degrees 30 minutes West 810.5 feet to point of beginning. LESS AND EXCEPT the following described parcel: A parcel of land located in the NE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 36, Township 19 South, Range 2 West, Shelby County, Alabama, more particularly described as follows: Commence at the Northeast corner of said Section; thence in a Westerly direction along the North line of said Section, a distance of 362.50 feet to the point of beginning; thence continue along last described course, a distance of 277.20 feet; thence 131 degrees 45 minutes left, in a Southeasterly direction a distance of 146.25 feet; thence 79 degrees 30 minutes left, in a Northeasterly direction a distance of 210.33 feet to the Point of Beginning. The southernmost point of said paved road being described opening onto Valley Dale Road at a point approximately one hundred sixty-five (165) feet
