(herein referred to as grantors) do grant, bargain, sell and convey unto William R. Pool, Jr. and wife, Gwen Pool

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

From the Southwest corner of the NW 1/4 of the NE 1/4 of Sec. 2, Twp. 20 South, Range 3 West. run northerly along the west boundary line of said NW 1/4 of the NE 1/4 of Sec. 2, Twp 20 South, Range 3 West for 655.0 feet to the point of beginning of the land herein described and conveyed; Thence continue northerly along the west boundary line of the NW 1/4 of the NE 1/4 of Sec. 2, Twp. 20 South, Range 3 West for 287.63 feet; thence turn an angle of 91 degrees, 58 minutes, 30 seconds to the right and run easterly 901.05 feet; thence turn an angle of 124 degrees, 11 minutes to the right and run southwesterly 274.25 feet; thence turn an angle of 1 degree, 52 minutes to the left and continue southwesterly 73.94 feet; thence turn an angle of 57 degrees, 44 minutes, 45 seconds to the right and run westerly 697.46 feet, more or less, to the point of beginning.
