- (2) That my property joined the property that was sold to Fata and Doris Bryant by Ethel Tyse, A widow, on or about March 8, 1978. Said property being about 2/3 of an acre in the S. E. 1/4 of Section 33, Township 21, and Range 1 West.
- (3) That I have lived on the property that joined said 2/3 of an acre for about the past 40 years.
- (4) That Walter and Beatrice Robinson lived on said property for at least 75 years; that they lived thereupon, visible, notorious and all who passed upon or along the premises could see, that the land was attentive, that the land was occupied by them, that the land was improved, cultivated and cared for by them and that they continuously occupied and maintained said land. Also that they claimed to own in fee simple.
- (5) THAT as far as I know they did in fact own said land.
- (6) That no one ever questioned or challenged their ownership of said land.

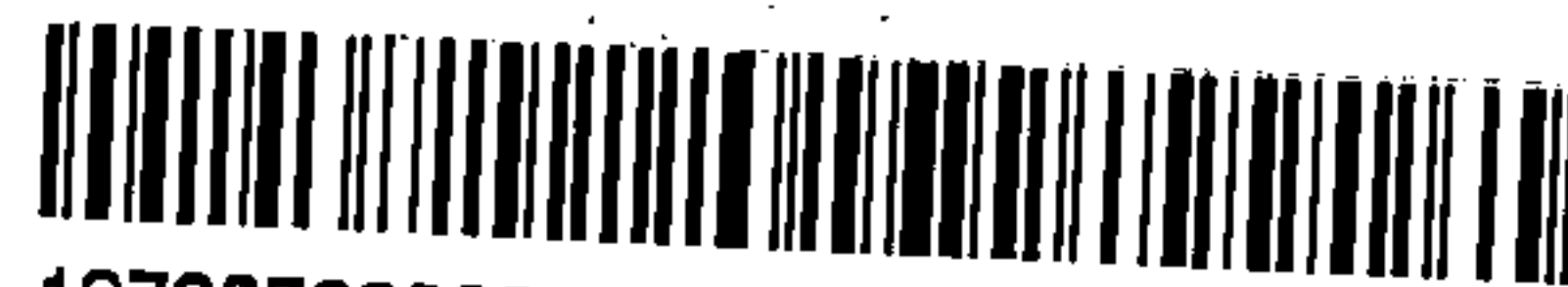
