This conveyance is subject to the following:

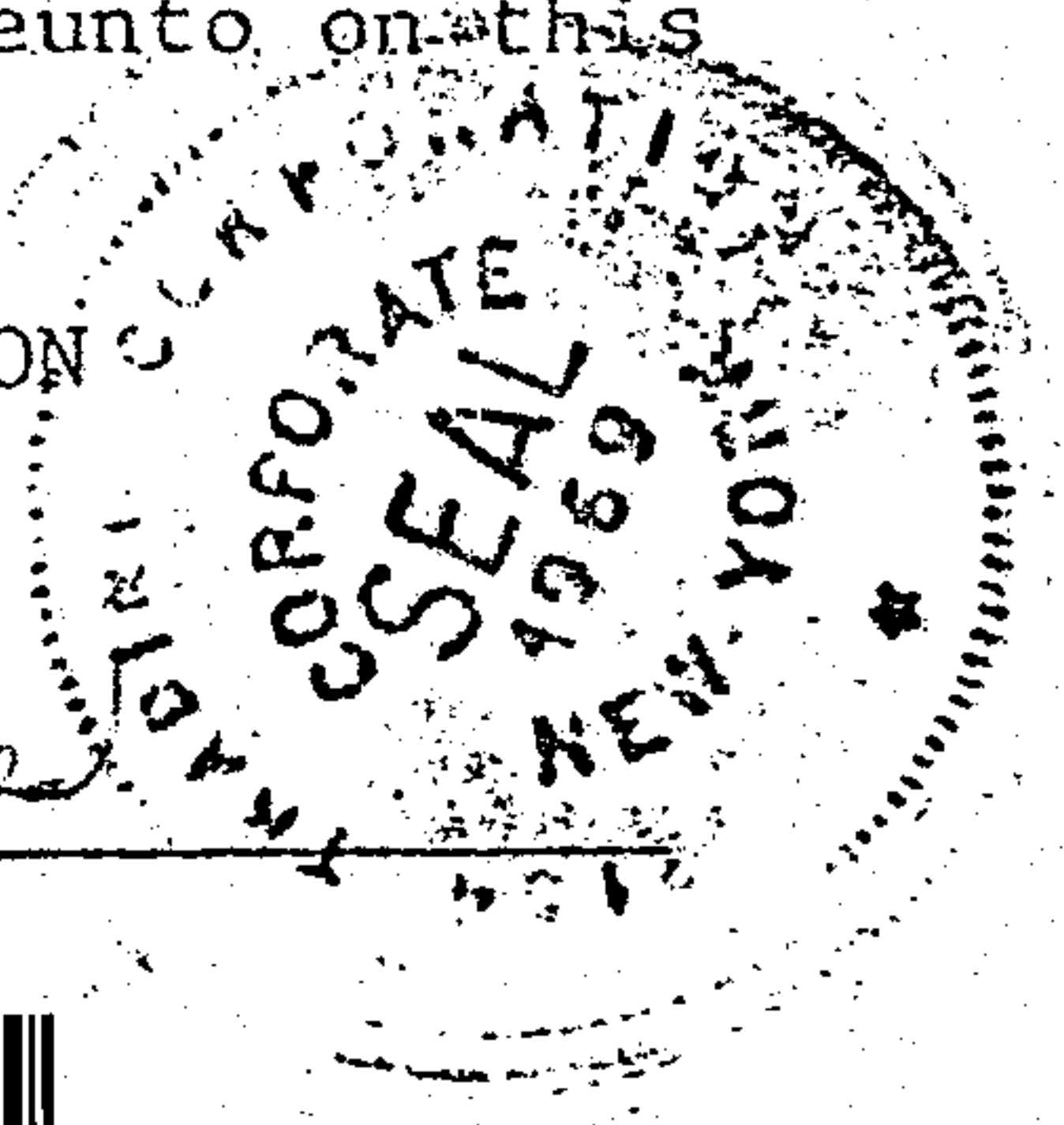
