This conveyance is subject to the following:

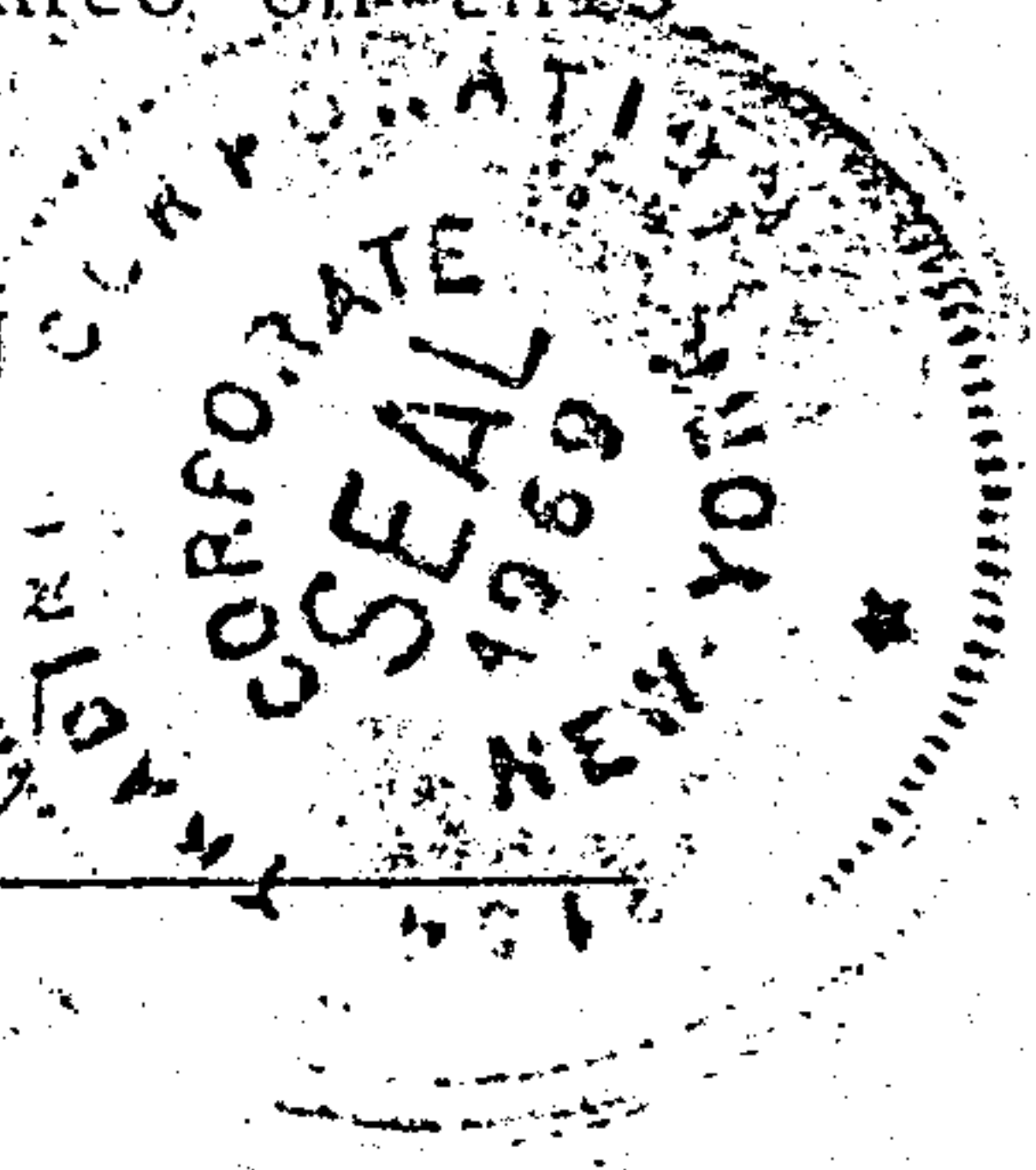
1. Ad valorem taxes due and payable October 1, 19 78.
