WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Sixty Thousand and No/100 (\$60,000.00) DOLLARS, to the undersigned grantor, OAK MOUNTAIN OFFICE PARK INC., a corporation, in hand paid by William W.Booth the receipt of which is hereby acknowledged, the said OAK MOUNTAIN OFFICE PARK INC., does by these presents, grant, bargain, sell and convey unto the said William W.Booth the following described real estate, situated in Shelby County, Alabama to-wit:

A parcel of land situated in the NW 1/4 of Section 6, Township 20 South, Range 2 West, Shelby County, Alabama more particularly described as follows: Commence at the Southeast corner of the SW 1/4 of the NW 1/4 of said Section; thence in a Westerly direction along the South line of said 1/4-1/4 Section a distance of 839.93feet to the Southeasterly right-of-way line of U.S.Highway 31; thence 115° 17' right, in a Northeasterly direction, along said right of way, a distance of 491.84 feet to the beginning of a spiral curve to the left; thence continue in a Northeasterly direction, along said right of way and said spiral curve, a distance of 99.0 feet to the point of beginning; thence continue along said right of way and spiral curve in a Northeasterly direction, a distance of 206.76 feet to the end of said curve and the beginning of a curve to the left, said curve having a radius of 2965.14 feet and a central angle of 01° 29' 36"; thence along arc of said curve, in a Northeasterly direction a distance of 77.28 feet to end of said curve; thence 88° 49' 48" right, measured from chord of curve, in a Southeasterly direction a distance of 184.96 feet to the beginning of a curve to the right, said curve having a radius of 25.00 feet and a central angle of 94° 55'; thence along arc of said curve, in a Southwesterly direction a distance of 41.41 feet to end of said curve; thence continue in a Southwesterly direction a distance of 256.86 feet; thence 85° 05' right, in a Northwesterly direction a distance of 202.56 feet to the point of beginning.




